Staff Reports

Shelly reported on the 2022-2023 Carbon County tax income, CCHEC received 73% of our estimated taxes compared to 63% by January 2022. CCHEC received 75% of our Sweetwater County Tax income compared to 51% by January 2022. Shelly and Jennifer are beginning the budget process for 2023-2024.

Jennifer reported on Community Engagement: We had a painting class last Thursday and another being planned for spring. Upcoming classes include Welding, Getting Ahead and CPR. The adult Certified Nursing Assistant class is full this semester.

Auto classes and resume building and interviewing will be postponed till February. Upcoming classes to watch for will be on painting techniques, home buying, diabetes management, and healthy relationships.
