## Institutional Financial and Performance Summaries

Last year, legislative appropriations committee chairs and the Legislative Fiscal Analyst's office communicated a desire for a simple, clear, and standardized approach to better understand USHE institutional finances and performance. Recognizing the benefit such an approach would also provide to the Board, the Commissioner's office developed a template to communicate institutional finances and performance to policymakers. The attached institutional summaries, including the eight technical colleges, will be provided to the legislature for the 2023 legislative session and are provided to the Board for review.





TTC All Revenue Sources and Other Additions





