Recommended Student Handbook Changes

May 15, 2024

Rochester Elementary Schools:

- Student drop-off times have been adjusted to 7:30 a.m.
- Mr. Randy Krepel noted that revisions at Rochester Intermediate School (RIS) align with the Illinois Principals Association (IPA) recommendations. These revisions include:
 - Updating policies in line with the IPA Model Student Handbook.
 - Amending the Sexual Misconduct Policy.
 - Updating Complaint Contact and Procedures.
 - Expanding the Definition for Distractions.
 - Adding Artificial Intelligence to the Dishonesty Policy.
 - Enhancing the Bullying Policy by ensuring families are notified within 24 hours and incorporating language addressing retaliation as a form of bullying.

Rochester Junior High School:

- Following the IPA Model Student Handbook, revisions include:
 - Updating the Sexual Misconduct Policy.
 - Revising Complaint Contact and Procedures.
 - Implementing an "Away for the Day" electronic device policy, requiring devices to be stored in lockers during instructional time, with specified check times.
 - Amending the Absences Policy to encourage attendance at civic events.
 - Enforcing a "No hoods" policy within the building.
 - Expanding the Definition for Distractions.
 - Prohibiting blankets from being brought to school.
 - Adding Artificial Intelligence to the Dishonesty Policy.

Rochester High School:

- In alignment with the IPA Model Student Handbook, revisions entail:
 - Updating the Sexual Misconduct Policy.
 - Revising Complaint Contact and Procedures.
 - Instituting a policy where students enrolled in AP English/Language Arts and achieving high standardized test scores must enroll in the most rigorous class the following year.
 - Introducing a new cell phone policy aimed at maximizing instructional time by allowing a full 60 minutes per block of cell phone-free instruction. Exceptions apply to IEP students and those with written permission from administrators. Clear consequences for violations are outlined.

Items for Future Consideration:

- Examination and potential adjustments to graduation groups at Rochester High School.
- Initiation of Diversity, Equity, and Inclusion dialogues and actions.

Grants Updates:

- Title I: Funds allocated to support student literacy, including resources for reading teachers, literacy aides, English Language Learners, and homeless students.
- Title II: Allocated for instructional improvement, including mentoring programs, professional development, and educational conferences.
- Title IV: Support for the College Now program, with provisions for students eligible for free or reduced-price lunches.
