

RESOLUTION abating a portion of the taxes heretofore levied for the year 2024 to pay debt service on the General Obligation School Refunding Bonds, Series 2019, of Community Unit School District Number 3A, Sangamon and Christian Counties, Illinois.

WHEREAS, the Board of Education (the "*Board*") of Community Unit School District Number 3A, Sangamon and Christian Counties, Illinois (the "*District*"), by a resolution of the Board adopted on the 23rd day of July, 2018 (the "*Bond Resolution*"), has heretofore issued and has outstanding its General Obligation School Refunding Bonds, Series 2019 (the "*Bonds*"); and

WHEREAS, a duly certified copy of the Bond Resolution has been filed in the offices of the County Clerks of Sangamon and Christian Counties, Illinois (the "*County Clerks*"); and

WHEREAS, the Board has determined and does hereby determine that funds are available (the "*Available Funds*") in the General Obligation School Refunding Bond and Interest Sinking Fund Account of 2019 of the District created by the Bond Resolution and from which principal of and interest on the Bonds is paid (the "*B&I Fund*"); and

WHEREAS, the Board has further determined and does hereby further determine that it is necessary that the District abate a portion of the taxes heretofore levied for the year 2024 to pay the principal of and interest on the Bonds by the amount of the Available Funds:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 3A, Sangamon and Christian Counties, Illinois, as follows:

Section I. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Abatement of Taxes. The tax heretofore levied for the year 2024 in the Bond Resolution shall be abated by the amount of the Available Funds, as more particularly described as follows:

Section 3. Filing of Resolution. Forthwith upon the adoption of this resolution, the Secretary of the Board shall file a certified copy hereof with the County Clerks and it shall be the duty of the County Clerks to abate said taxes levied for the year 2024 in accordance with the provisions hereof.

Section 4. Severability. If any section, paragraph, clause or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

Section 5. Repeal. All resolutions or parts thereof in conflict herewith be and the same are hereby repealed, and this Resolution shall be in full force and effect forthwith upon its adoption.
