WHEREAS, the Board of Education (the "Board") of Community Unit School District Number 3A, Sangamon and Christian Counties, Illinois (the "District"), by resolution adopted on the 22nd day of February, 2023 (the "Resolution"), did provide for the issue of \$21,310,000 General Obligation School Bonds (Alternate Revenue Source), Series 2023, of the District (the "Bonds"), and the levy of direct annual taxes sufficient to pay the principal of and interest on the Bonds (the "Pledged Taxes"); and

WHEREAS, the Resolution established a special fund of the District known as the "Alternate Bond Fund of Series 2023" (the "Bond Fund") for the repayment of the Bonds; and

WHEREAS, the Board hereby determines that Pledged Revenues (as defined in the Resolution) or other lawfully available funds are available and on deposit in the Bond Fund in an amount sufficient to pay the principal of and interest on the Bonds when due, so as to enable the abatement of all of the Pledged Taxes levied for the year 2024; and

WHEREAS, the Board hereby further determines that it is necessary and in the best interests of the District that the Pledged Taxes levied for the year 2024 to pay the Bonds be abated in their entirety:

NOW, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of Community Unit School District Number 3A, Sangamon and Christian Counties, Illinois, as follows:

Section 1. Abatement of Tax. The Pledged Taxes levied for the year 2024 in the Resolution are hereby abated in their entirety.

Secretary of the Board shall file a certified copy hereof with the County Clerks of Sangamon and Christian Counties, Illinois, and it shall be the duty of said County Clerks to abate the Pledged Taxes levied for the year 2024 in accordance with the provisions hereof.

Section 3. Effective Date. This Resolution shall be in full force and effect forthwith upon its adoption.
