- **August 22, 2024** Applicants reviewed. There were ten (10) applicants, of which four (4) qualified to move forward in the process.
- **September 9, 2024** Interviews conducted with the four (4) qualified candidates. Applicants were each given a one (1) hour interview with the interview panel. The interview panel consisted of,
 - o Lee Weinstein President, Q-Life Board of Directors
 - o Matthew Klebes City Manager, City of The Dalles
 - o Tyler Stone County Administrator, Wasco County
 - o Roger Kline General Manager/CEO, Northern Wasco County PUD
 - o Kara Salazar HR Generalist, Northern Wasco County PUD
- The interview panel debriefed and narrowed their choices down to two (2) candidates. Both candidates had experience and attributes which could greatly benefit Q-Life and their vision. It was decided to have each candidate meet with Mr. John Amery, Q-Life Consultant, to offer each candidate time to understand and learn more about the technical side of the position and allow Mr. Amery to offer any additional insight into the two candidates to help the panel make their final decision.
