- Coordinated Career Pathways (CCP) proposals approved from Impact Solution & Mains'I.
- Job Training Center of Tehema County proposal approved to explore potential opportunities for job development supports in Tehema.
- Participated in local job developers meeting and collaboration monthly.
- Sub Minimum Wage ended with payments made to individuals retroactive to May 10<sup>th</sup>.
- Participated in many IDT meetings to support SCs, vendors, and consumers navigate next steps and plans for moving forward.
- Continued work with Impact Solution, ARC of Butte Co, WTC, & Mains'I to draft ISPs to support the transition to the ILS model of job support.
- Continued discussion with DDS & All's Well to explore options to access staffing for vendors through DSP Internship Pilot Program- we have one vendor with 2 interns and plans to reach out to get other providers connected.
