Orthopeadic Surgery DOP Emergency Medicine Core DOP Revision a. For the EM core DOP

- i. Add ACLS and PALS for all sites with the exception of PALS at BHMC
  - 1. Rationale: children can be seen in any of our EDs but are seen in a dedicated pediatric ED at BHMC where it is staffed separately
- ii. Add ATLS for BHN and BHMC
  - 1. Rationale: as trauma centers, those working in the EDs would be expected to work traumas
- b. For the Pediatric EM core DOP
  - i. Add ATLS for BHMC
    - 1. Rationale: as a pediatric trauma center, this level of preparedness is expected
