# PURPOSE

Board Policy 1A.1 Minnesota State Colleges and Universities Organization and Administration, Part 6. Board Policies and System Procedures requires board review and approval of proposed board policy changes and that each board policy is reviewed at least once every five years.

# **BACKGROUND INFORMATION**

The proposed amendment consists of updates and stylistic changes since the last time the policy was reviewed. It acknowledges tailgating and campus-owned liquor licenses. It also clarifies that Marijuana remains a prohibited controlled substance despite recent changes in State law.

# **RECOMMENDED ACTION (FIRST READING DRAFT)**

The Finance and Facilities Committee recommends that the Board of Trustees approve the proposed amendment to Policy 5.18 Alcoholic Beverages or Controlled Substances on Campus.

3	Part 1. Policy StatementPurpose
4	The Board of Trustees requires that any college or university using alcohol and/or controlled
5	substances must be in compliance with this policy. It is the policy of the Board of Trustees that
6	any college or university using alcohol and/or controlled substances will do so only in
7	accordance with this policy.

9	Part 2. Compliance with Federal Law Use or Possession of Alcohol and Controlled Substances
10	at Minnesota State Colleges and Universities and System Office.

12	Subpart A. Compliance with Federal Law.
13	In order to comply with Federal law, including, but not limited to, the Drug-Free Schools and
14	Communities Act (34 CFR Part 86), the Drug- Free Workplace Act (34 CFR Part 85) and the
15	Campus SecurityClery Act, the Minnesota State <u>c</u> Colleges and Uuniversities and the system
16	office will adopt and implement a policy which is designed to prevent abuse of alcohol and the
17	use of controlled substances.

19	Subpart B.Part 3. Compliance with State Law.
20	Minnesota State Colleges and Universities prohibits unlawful use, possession, production,
21	manufacture, and distribution of alcohol and other drugs and controlled substances.

23	Part 4. Subpart C. Policy. Applicable Locations
24	Except as provided in this policy, unlawful use, possession, production, manufacture, and
25	distribution of alcohol and other drugs and controlled substances , the possession, use, sale or
26	distribution of alcoholic beverages and 3.2% malt liquor at Minnesota State Ecolleges and
27	Universities and institution-sponsored events on or off campus is prohibited.

29	Subpart DPart 5. Exception for Instructional Purposes.
30	Use or possession of alcohol in laboratory and classroom -instruction, /experimentsresearch or
31	approved academic programs is not prohibited.

33	Part <del>3<u>6</u>. Responsibilities.</del>

35	<u>Subpart A. Approver Responsibilities</u>
36	The chancellor for the system office and the president for the college or university are-
37	delegated authority to approve use of alcohol at specific special events on campus or
38	college or university sponsored events off campus. Approval shall be consistent with the
39	system office or campus drug and alcohol policy and with system procedures. The
40	procedures shall address the following: compliance with local ordinances and state law
41	relating to sale, possession or consumption of alcohol; providing adequate dram
42	shop/public liability insurance; and any other matters deemed necessary by the
43	chancellor.

#### 5.18 Alcoholic Beverages or Controlled Substances on Campus

#### Part 1. Purpose

The Board of Trustees requires that any college or university using alcohol and/or controlled substances must be in compliance with this policy.

# Part 2. Compliance with Federal Law

In order to comply with Federal law, including, but not limited to, the Drug-Free Schools and Communities Act (34 CFR Part 86), the Drug- Free Workplace Act (34 CFR Part 85) and the Clery Act, Minnesota State colleges and universities and the system office will adopt and implement a policy which is designed to prevent abuse of alcohol and the use of controlled substances.

#### Part 3. Compliance with State Law.

Minnesota State prohibits unlawful use, possession, production, manufacture, and distribution of alcohol and other drugs and controlled substances.

#### Part 4. Applicable Locations

Except as provided in this policy, unlawful use, possession, production, manufacture, and distribution of alcohol and other drugs and controlled substances at Minnesota State colleges and universities and institution-sponsored events on or off campus is prohibited.

#### Part 5. Exception for Instructional Purposes

Use or possession of alcohol in laboratory and classroom instruction, research or approved academic programs is not prohibited.

#### Part 6. Responsibilities

#### Subpart A. Approver Responsibilities

The chancellor for the system office and the president for the college or university are delegated authority to approve use of alcohol at specific special events on campus or college or university sponsored events off campus. Approval shall be consistent with the system office or campus drug and alcohol policy and with system procedures. The procedures shall address the following: compliance with local ordinances and state law relating to sale, possession or consumption of alcohol; providing adequate dram shop/public liability insurance; and any other matters deemed necessary by the chancellor.

#### Subpart B. Requestor Responsibilities



The individual or group seeking to use alcohol at specific special events on campus or college or university sponsored events off campus must obtain advance approval from the Chancellor or appropriate college or university president.

#### Part 7. Accountability/Reporting.

Records regarding approval of the use of alcohol at specific events must be maintained by the college or university in accordance with approved records retention schedules.
