PURPOSE

Board Policy 1A.1 Minnesota State Colleges and Universities Organization and Administration, Part 6. Board Policies and System Procedures requires board review and approval of proposed board policy changes and that each board policy is reviewed at least once every five years.

BACKGROUND INFORMATION

The proposed amendment consists of technical edits such as adding “Colleges and Universities” after Minnesota State in Part 1 and adding U.S. before “Copyright Act” in second paragraph of Part 1.

1 **3.27 Copyrights**

2

3 **Part 1. General Statement**

4 Copyright owners have exclusive rights with respect to their creation of original works.

5 Minnesota State Colleges and Universities promotes the recognition and protection of these
6 rights, including the rights of reproduction, preparation of derivative works, distribution,
7 display, and performance.

9 Reproduction and use of copyrighted works in accordance with fair use limitations and Sections
10 110(1) and (2) of the U.S. Copyright Act can further teaching, research, and public service at
11 Minnesota State colleges and universities. Where proposed uses of copyrighted works exceed
12 those permitted by fair use and other statutory exceptions, permission to use the copyrighted
13 works should be obtained from the copyright holder.

15 Consistent with the mission of the Board of Trustees and the distinct missions of the colleges
16 and universities, the board supports the creation and sharing of new knowledge for course
17 development and to improve student learning through ~~e~~Creative ~~e~~Commons licenses and open
18 education resources (OER).

19

20 **Part 2. Applicability**

21 This policy applies to colleges, universities, the system office and their respective employees
22 and students, and to works in which colleges, universities or Minnesota State has a legally
23 recognized interest.

25 **Part 3. Definitions**

26 The following definitions apply to this Policy and to Procedure 3.27.1 Copyright Clearance.

27

28 **Copyright**

29 A form of protection granted by federal law for original works of authorship that are fixed in
30 a tangible medium of expression. Copyright covers both published and unpublished works.

31

32 **Copyright Compliance**

33 The actions of colleges, universities, the system office and their respective employees and
34 students that ensure proposed uses of materials comply with copyright laws and do not
35 infringe on the intellectual property rights of copyright owners.

36

37 **Part 4. Copyright Notice**

38 A copyright notice (Copyright © [year] College or University Name) may be placed on college,
39 university, and Minnesota State owned materials that will be made available to the public. The
40 date in the notice should be the year in which the materials are first published, i.e. distributed

41 or made available to the public or any sizable audience. Where a work is revised over a period
42 of time, a range of years should be used.

43

44 **Part 5. Copyright Registration**

45 Prior to commercialization of works in which a college, university, or the system office has an
46 ownership interest, such works should be registered with the U.S. Copyright Office in the
47 name(s) of the copyright owner(s).

48

49 **Part 6. Copyright Compliance**

50 Colleges, universities, and the system office shall develop and implement policies, procedures,
51 and practices to comply with federal copyright laws.
