Performance Levels (or colors) are based on two factors:

1. Current Year results (spring 2024)
2. Whether results improved from prior year (2023)

Those results are then used for reporting on the CA Dashboard as state indicators are determined using current year performance and the **difference** from prior year (or change) to show **growth** or **decline**.
