## **RESOLUTION 20-22**

## A RESOLUTION AUTHORIZING AN EXCEPTION TO COMPETITIVE BIDDING AND/OR PRICING QUOTES FOR THE CITY OF SAINT PAUL TO PURCHASE HEAVY EQUIPMENT

WHEREAS, the City Code of Ordinances (CCO) Title 4 – Revenue and Finance, Chapter 4.15 – Purchasing, Section 4.15.030(a) requires a competitive bid process for purchases over \$50,000, but the City Council, by resolution, may waive competitive bid procedures if provided in Section 4.15.040; and,

WHEREAS, Section 4.15.040(c)(4) allows for exceptions to the competitive bid process for sole source purchases where detailed justification is obtained that establishes beyond a doubt that the vendor is the only source available to provide the item or service required; and

WHEREAS, it is the intent of the City to purchase two new piece of heavy equipment in 2021 that cost over \$150,000 each; and,

WHEREAS, the City would like to standardized it's heavy equipment fleet with the same make of equipment for the purpose of gaining efficiencies in maintenance and repair; and,

WHEREAS, the City currently has a number of newer Caterpillar equipment, including a loader and grader; and,

WHEREAS, it is the intent of the City to purchase a Caterpillar 309 Mini Excavator ("Excavator") with accessories at the estimated price of \$169,657; and,

WHEREAS, it is the intent of the City to purchase a Caterpillar 926M Loader ("Loader") with accessories at the estimated price of \$201,125; and,

WHEREAS, the only authorized dealer for Caterpillar for Alaska is NC Machinery in Seattle, Washington; and,

WHEREAS, the shipping logistics to Saint Paul Island are a challenge and it is most cost effective to ship the Excavator and Loader out of Seattle, Washington; and,

WHEREAS, it is in the best interest of the City and the public to use public funds conservatively and seek the best value; and,

NOW, THEREFORE, BE IT RESOLVED the Council of the City of Saint Paul, Alaska:

Section 1: Approves the purchase of Excavator and Loader for the City in accordance with the approved CY2021 budget; and,

Section 2: By authorizing this resolution waives the competitive bidding process for the purchase of the Excavator and Loader pursuant to Section 4.15.040(c)(4), after finding that beyond a doubt NC Machinery, as the sole authorized Caterpillar dealer for Alaska, is the only source available to provide the items required; and,

Section 3: Authorizes the City Manager to work with NC Machinery to purchase the Excavator and Loader for the City in accordance with the approved CY2021 budget.
