Out for proposals

SOA CBDG and AEA for Bulk Fuel Facility Upgrades

On March 7th the full RFP was posted on the city web page along with The Plans Room with a Prebid meeting on held on March 21st. We had five construction firms join the meeting that lasted nearly an hour. The following week I responded to many written questions, long lead times for the two tanks is a concern that we'll need to address after the award. All proposals are due Tuesday 8th by 4pm, so we should have an award by the time of this meeting.

Healthy Food Financing Initiative Planning Grant

On March 28th we sent out an RFQ for Community Farm Planning and Predevelopment. With four firms contacted. One firm declined and three responded with interest. The proposals are due on April 10th. This planning will include a Feasibility Study, Business Plan, Infrastructure Plan and a Conceptual Design for the retail space. These predesign components are needed to pursue design and construction funding.



Project / Grant Updates

USDOT Safe Streets and Roads for All Grant

Public Meeting held on March 29th with a very positive community turnout and input. KUNA will prepare the final Regional Transportation Safety Action Plan within the next two weeks.

EDA Small Boat Harbor Utilities Project

<u>*Easements*</u> – Kuna Engineering has updated the drawings for the easements the City is requesting from TDX. City's legal counsel has drafting the easement agreement to send to TDX for review.

<u>Bid Documents</u> – Kuna Engineering is completing the bid docs.

USDA RUS Loan for Electric Utility Upgrades

<u>USDA Loan Status</u> – The USDA loan has been approved. We are in the process of meeting special loan conditions involving the debt ratios.


USDA RUS HECG for Airport Feeder Replacement

USEPA STAG for Aalax Solid Waste Facility

The bids for construction are due to ADEC VSW on January 15, 2025, VSW has determined the low bidder but now it seems they are unresponsive. We will keep pressuring VSW for an update.
