8.05.010 Department established.

There is established a Department of Public Safety consisting of four separate divisions; Patrol, Emergency

Management/Services, Emergency Dispatch, and Harbor divisions. The Department of Public Safety provides

police, fire, emergency medical, search and rescue, emergency dispatch, emergency management, and harbor

safety services. The Department of Public Safety shall be responsible for the protection of life and property of
the citizens. [Code 1979 § 12.01.010.]

8.05.020 <u>Director of Public Safety.</u>

(a) The <u>Director of Public Safety</u> shall be the head of the <u>Department of Public Safety</u>. The <u>Director of Public Safety</u> is an administrative officer of the City appointed by the City Manager and removable by the City Manager.

8.05.030 Duties and responsibilities of Director of Public Safety.

(a) It shall be the duty of the Department of Public Safety (Department), through the Director of Public Safety, to perform the following duties and responsibilities:

(1) Carry out the duties and responsibilities of the Department under the supervision and control of the City Manager;

(2) Plan, direct, supervise, and coordinate the division activities of the Department;

(11) Communicate and maintain coordination with local, tribal, state, federal governmental agencies and local businesses regarding community public safety issues, programs, and services,

(12) Answer inquiries from citizens concerning public safety programs and services.

(13) To have charge of and operate the City's holding facility:

(14) Insure the participation of Department personnel in the Saint Paul Island Local Emergency Planning Committee (LEPC);

(15) Cause lives and property to be protected from destructive losses due to fire and/or other catastrophic

(16) Assure the overall training, preparedness, and safety of Department personnel and the availability and readiness of appropriate apparatus and equipment;

(17) Cause an investigation for the purpose of assisting in the determination of cause and origin of fires resulting in property damage, injury or death;

(18) Inspect or cause to be inspected, at reasonable hours and upon reasonable notice to the owners or occupants, all buildings and structures and premises which are or are suspected of being in an unsafe or dangerous fire prevention or control condition;

(19) Assure the volunteer members of the fire, emergency medical services, and search and rescue are permitted to organize into a voluntary departmental association, elect their own officers and adopt bylaws. **Deleted:** [Code 1979 § 12.01.020.]

(a) A Police Corporal or Sergeant shall be hired to head of the Patrol Division of the Department of Public Safety. The Police Corporal or Sergeant is a State of Alaska certified police officer that will serve as the supervising officer of Division.

8.05.050 Duties and responsibilities of Patrol Division Supervisor.

- (a) It shall be the duty of the Patrol Division Supervisor, to perform the following duties and responsibilities:
 - (1) Select all police officers in consultation with the Director of Public Safety, but all such appointments and the number thereof shall require the prior written approval of the City Manager. The Police Corporal or Sergeant evaluates and documents the performance of all subordinate police officers, administers the personnel rules of the City to ensure the fair treatment of all employees, administers and documents disciplinary actions, and fires employees with the prior written approval of the City Manager;
 - (2) Plan, direct, supervise, and coordinate the division activities of the Department of Public Safety.
 - (2) To apprehend and arrest and bring to justice all violators of the ordinances of the City;
 - (3) To suppress all riots, affrays, and unlawful assemblies which may come to their knowledge, and generally to keep the peace;
