# Advocacy update



MercyOne is the largest health care system in Iowa. As we strengthen our advocacy structure across Iowa, we will be engaging with our policymakers on a regular basis or as necessary to:

- Influence health policy at all levels of government.
- Build relationships to better inform and persuade policymakers to develop, change or maintain policy to meet the needs of our industry.
- Identify the regulatory challenges within our organization, assess the issue and proactively bring forth solutions.

For the 2025 Iowa Legislative Session, here are the following priorities we are focused on as a system:

#### **Grow workforce**

# Support incentives for health care recruitment and retainment

 Leverage \$30 million Workforce Opportunity Fund; continue to support policies that strengthen and expand exposure to the health care field; education/training pathways and retention efforts to keep high-demand jobs in Iowa

#### Support efforts to prevent workplace violence

 Pursue policies the improve health care workforce safety and reduce violence against our colleagues, students and volunteers within our facilities

#### Strengthen physician recruitment and retainment

 Evaluate approaches to our physician pathways in lowa, along with our residency and fellowship programs, to create capacity and optimize retainment in lowa

Sustain our not-for-profit faith-based Mission

#### Pursue strategies to hold payers accountable

- Support prior authorization relief to reduce provider administrative burden
- Support increased accountability in payer payment policies Ensure Patient Access (Pharmacy Benefit Manager Reform)
- Strengthen fair payment for pharmacy and pharmacist services

#### Improve community health

#### **Sustain enhanced Medicaid reimbursement**

 Maintain use of hospital provider participation funds to finance Medicaid hospital quality programs and improve access to care for Medicaid managed care beneficiaries

#### Improve access to maternal care services

 Collaborate with the State to identify a regional care delivery approach, specifically for maternal care services

In addition to above, we are fortunate in Iowa to have a Governor who is leading the way in her policy recommendations. Here is the link to her bill, and a summary below: HSB 191

#### Health care workforce

- Consolidate the state's five existing health care professional loan repayment and recruitment programs, more than double the funding to \$10 million, and open the programs to all eligible applicants including those educated or trained out of state
- Create approximately 115 new residency slots over four years at the state's 14 teaching hospitals by leveraging additional federal graduate medical education funding through the state's Medicaid program
- Invest \$3 million in Health Care Credentialing grants for employers to train and educate nurses, CNAs and LPNs

#### Maternal health

- Invest \$642,000 into unbundled Medicaid maternal rates
- Increase Medicaid rates for certified nurse midwives and add doula services as a covered Medicaid benefit
- Seek federal approval for a Medicaid waiver to provide rate flexibility with a goal of incentivizing a hub-andspoke model of care

#### Cancer research

 Invest \$1 million to establish a new partnership between the Iowa Department of Health and Human Services and the University of Iowa to research the behavioral, genetic and environmental factors driving Iowa's high cancer rate

#### Certificate of need

- Eliminate the Health Facilities Council and shift the review to professional staff at IHHS
- Hire a health care economist at IHHS to support the CON process and help develop a report on the state's health care economy and CON process

#### Health information exchange

 Provide IHHS with the authority to competitively procure and manage the state's health information exchange (HIE) network and replace the existing board with an advisory committee.
