Colet Richardson added a monthly average to provide a comparison with average expenditures. As of the end of January, 54.75% of the WWDC total budget has been spent with \$799,251 remaining, 93.95% of the 2023 grant funds have been spent with \$28,811 remaining, and 5.4% of the 2024 grant funds have been spent with \$770,440 remaining. Regarding local funds, \$14,563,590 has been spent with \$3,259,255 remaining.
