- 1. I recently received a notification that I need to take the Jurisprudence Assessment Module (JAM). Is it an official notification that I must follow?
 - a. The NH JAM is required to be taken each April, May, or June of years ending in "0" and "5" (Phy 402.03) – Needs to be updated, leave off for now?
- 2. I am interested in taking a continuing education course. Where do I go to get it approved for my license renewal?
 - a. The NH PTGB does not pre-approve courses to apply toward continuing competence requirements for license renewal. You can find information regarding continuing competency requirements at Phy 406.01 Maintenance of Continuing Competence Requirements.
- 3. I am interested in performing dry needling on my patients. Is it in the NH scope of practice and what are the requirements for education?
 - a. The NH PTGB directs you to follow guidance from FSBPT and the APTA. Resources can be found here: <u>FSBPT > Free Resources > Regulatory</u> <u>Resources > Dry Needling Competencies</u>
- 4. I don't like the way my physical therapist treated me. How do I file a complaint to the NH PTGB?

- 5. Is there direct access in New Hampshire?

- a. Per 328-A:9 Lawful Practice, a physical therapist is only required to refer a patient or client to appropriate health care practitioners when:
 - (a) The physical therapist has reasonable cause to believe symptoms or conditions are present that require services beyond the scope of practice; or (b) Physical therapy is contraindicated. (Section 328-A:9 Lawful Practice.)
- 6. **TABLED pending Board Counsel research** I think my patient has been using cannabis before therapy sessions. Can I still see them? Can I recommend the use of cannabis for my patient who has persistent pain?
- 7. I have heard conflicting information regarding the need to co-sign my PTA's notes. Do I have to co-sign everything?
 - a. 328-A:11 Obligations of Licensees A physical therapist assistant shall work under a physical therapist's general supervision. A physical therapist assistant shall document care provided and shall report to a supervising physical therapist any status in a patient requiring a change in the plan of care. The supervising physical therapist shall review and co-sign all notes during each reevaluation. Section 328-A:11 Obligations of Licensees.
