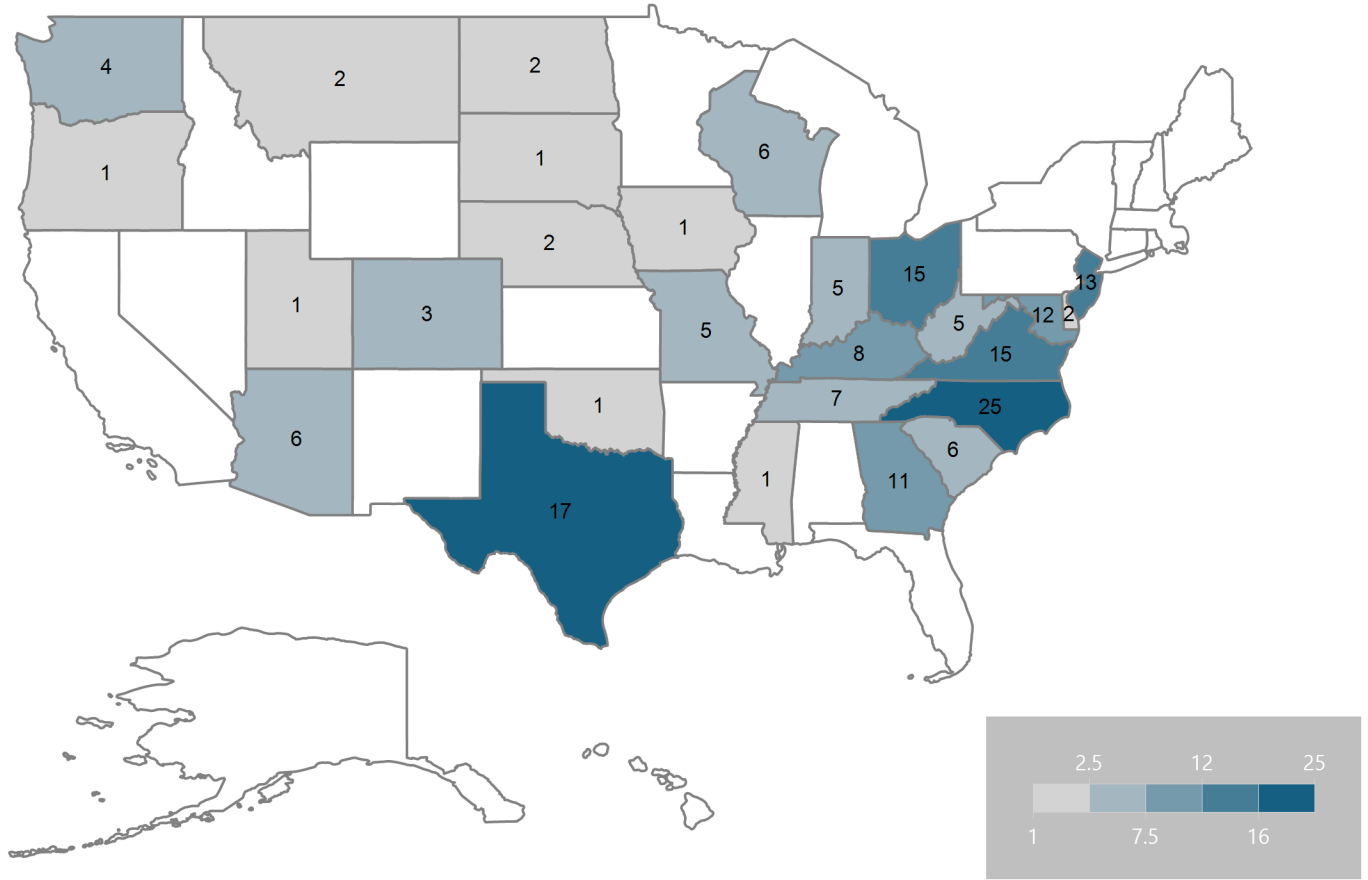

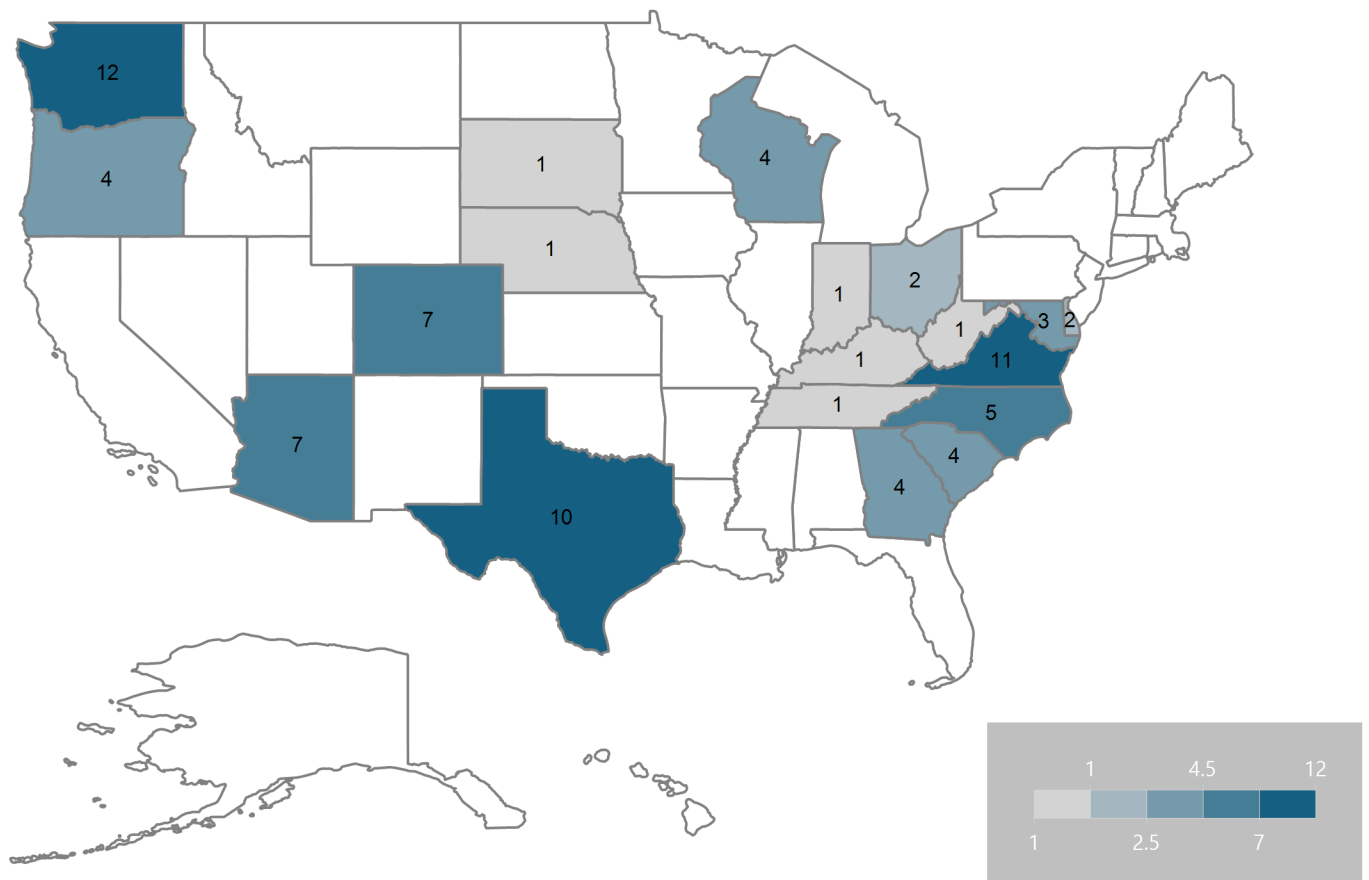
Where do individuals live that have a Compact Privilege for NEW HAMPSHIRE? (Coming From)
