1 Arapahoe Community College is proposing to increase their student activity fee from \$4.99 per credit hour to \$7.00 per credit hour, both capped at 12 credit hours as well as proposing to assess a health and wellness fee of \$11.19 per semester to students taking classes exclusively online.

2 Northeastern Junior College (NJC) is proposing to change its associated student government fee from \$3.00 per credit hour to \$3.50 per credit hour

3 Front Range Community College (FRCC) is proposing to consolidate several campus-specific fees into college-wide fees, including a student activity fee, building fee, and technology fee, as well as instituting a wellness fee.

4 Morgan Community College (MCC) is proposing to charge \$6.00 per credit hour for a new Technology fee. Referendum passed.
