I look forward to connecting with you all on the Board Chair call on 2/5/2025, but I wanted to catch you before then with a few updates from Governor Ayotte and her expectations for this legislative session. The text of bills has just been completed by legislative staff, and OPLC will be providing you with an update on legislation that pertains either specifically to your board or to the office as a whole.

Neither the OPLC, nor any board, is authorized to take a position on any bill without express permission from the Governor's Office. (This is the case across all state agencies). If any board would like to designate a member to speak on behalf of the board, any testimony must be neutral and factual in nature. Any board that would like to ask the Governor's Office for permission to take a position on a bill can submit written testimony to me through Board Counsel, and I will review that request with the Governor's Office. I will do my best to respond to you as quickly as possible. Will you please assist me in ensuring that your board members are made aware of this at your next scheduled meeting?

Thank you for your attention to this matter, and I am happy to answer any questions that you may have.
