A. Mindy Hall DMD

Spoke about her stance on DEN 304 Moderate sedation guidelines. She is in opposition to the proposed rules for pediatric dentists. She stated she would no longer be able to sedate those under 13 under the new guidelines. She is hoping the Board of Dental examiners would adopt national guidelines on sedation for pediatric patients.

B. Sarat Thikkurissy

Spoke in opposition to DEN 304, he warned of downstream implications with the current providers. He provided many facts on the current situation in New Hampshire. Spoke to provide the facts around the current situation in New Hampshire. Sarat asked for the following amendment to be made to Den 304.03

“Moderate sedation permits with pediatric qualification which authorizes a qualified dentist, with additional training in pediatric sedation, licensed by the state of N.H., to administer moderate sedation only to patients 9 years of age and older in a dental facility that has the required facility permit or a facility hosting permit”

Sarat asked for the following amendment to be made to Den 304.03,

“Advanced training in anesthesiology and related academic subjects beyond the undergraduate dental school level in a training program as described in Part III C. of the American Dental Association “Guidelines for the Use of Sedation and General Anesthesia by Dentists”, revised 2016, as specified in Appendix II; or An advanced dental education

program in either dental anesthesiology or oral and maxillofacial surgery as described in the Commission”

C. Richard Neal, DMD

Provided written testimony, he testified to mainlining and expanding the guidelines that allow pediatric dentists to utilize moderate sedation for patients under nine. Further in the letter Neal testified that,

“Currently, the proposed guidelines would prohibit pediatric dentists from using moderate sedation on patients aged eight and under. This restriction not only undermines the capabilities of trained professionals but also goes against current best practices as outlined by the American Academy of Pediatric Dentistry (AAPD) and the American Academy of Pediatrics (AAP). The guidelines must be updated to reflect these standards, which recognize moderate sedation as an essential tool in providing safe and effective care.”

D. Tommy Burke DMD, MD

Spoke to PALS certification and would like guidance from the Board and encourages the Board to listen to the comments brought before the Board.
