Metrics Report November 2024

Leveraging Competitive Funding & Partnerships

Average Fleet Age

- 6.02 years – This is an increase of 6.48 percent from November 2023.

• Subsidy per Passenger

The subsidy per passenger increased in November of 2024 in comparison to last November by \$3.99 or 27.8 percent. Costs are up about 220k, ridership is slightly down on the FR. New employees are not contributing to service hours.

• Admin Cost Per Revenue Hour

- Administrative Overhead cost per hour has decreased by \$4.77 or 17 percent compared to November of 2023 to November of 2024.

Enhancing Connectivity

BCRTA Transit App Users

- BCRTA had 7,100 users during the month of November for Transit App. This is a 22.3 percent increase from the previous year.

• BCRTA Transit App Downloads

BCRTA tracked 1,320 new downloads for the Transit App in November of 2024. This is a
65 percent increase from the previous year.

• BGO App Rides/Total BGO Rides

- 53.25 percent of all trips were booked utilizing the mobile application. This is a 39.47 percent increase from November of 2024.

BGO App Downloads

- BCRTA had 602 new users downloading the mobile application. This is an 84.88 percent increase from November of 2024.

• BGO Mobile Payment & Total Trips

- BCRTA completed 7,007 non-contracted trips in November of 2024. This is a 77.3 percent increase in completed, non-contracted trips from November of last year.
- No trips were paid for using the BCRTA mobile application (BrainTree).
- 42.78 percent of all trips were paid for using EZFARE.

Improving Mobility & Eliminating Barriers

• Passengers Per Revenue Hour

- Fixed routes had 12.69 passengers per revenue hour in November of 2024, this is a 6.6 percent decrease from November of 2023.
- Demand Response service had 1.87 passengers per revenue hour in November of 2024, this is a zero percent increase from November of 2023.
- 2024 Total trips (BGO, BCARE, Contracted Trips) 59,683. This is a 37.2 percent increase from 2023 and a 204.5 percent increase comparing 2024 to 2019.

Accidents and Injuries

- Fault Total BCRTA had five (5) at fault accidents in November of 2024.
- No Fault Total BCRTA also had seven (7) no fault accidents.

• Target Operator Staffing

- 80%
- This number has increased by 21.43 percent from the previous year.
- The yearly average was 79.15 percent.

Denials and Refusals/ Total BGO Trips

 32.95 percent of all requested BGO trips were refused or denied in November of 2024 due to time and capacity limitations. This is a 4.54 percent decrease from November of 2023.

Supporting Employers

• CincyLink Total Trips

- CincyLink had 2,008 riders. This is a 42 percent decrease from November of the previous year.

BGO Employment Trips

- BCRTA completed 2,494 BGO trips for employment in November of 2024, this is a 33.56 percent increase from the same month the previous year.

Developing Multimodal Infrastructure

Goal

• Days Until Chestnut Fields Completed
