• As of July 1, 2021, student-athletes are now able to earn compensation for the use of their Name, Image or Likeness.

### What does this mean?

- Student-Athletes are allowed to earn money from:
  - Social Media promotions and influencer activities
  - Sale of autographs
  - Starting their own business
  - Appearance in TV in print advertisements for products or services
  - Personal appearances
  - Sale of merchandise owned by the student-athlete (that is not provided by VMI)
  - Providing private sport lessons or running an own camp or clinic



## Also, student-athletes can:

- Hire an agent or other professionals to help secure and assist with NIL opportunities.
  - Lawyers
  - Tax Professionals
  - O Social Media Managers
  - Brand Consultants



# NCAA Guidance - All student-athletes NIL activities must meet these rules:

- No pay for play
- No recruiting inducements and a deal can't be contingent on enrollment into the school
- All activities must be quid pro quo, and
- Student-athletes must disclose their NIL IF they request assistance from the institution or college.



### **VA House Bill 1015**

• As of July 1, 2024, the Virginia bill will allow public and private institutions of higher education within the Commonwealth to create and facilitate name, image or likeness opportunities for student-athletes. In other words, NIL operations will become more streamlined through school involvement. Bringing NIL operations in-house will enable schools to efficiently manage monitoring and funding.

### Summer Undergraduate Entrepreneurship Program

VMI's Summer Undergraduate Entrepreneurship Program (SUEP) will consist of a five-week summer course, field trips to start-up companies and incubators, and interaction with invited speakers, chosen from alumni and business leaders. The 2024 SUEP is offered free of charge to successful applicants through a grant from the Jackson-Hope Fund. Also, program participants will earn 3 elective credits.


