The course will enable the course to include a more rigorous and in-depth research project, additional opportunities to hone and demonstrate effective presentation/oral communication skills, additional collaborative assignments, and instruction and assignments related to career preparation/development. The change will not affect the total credit hours required for the major/degree. 0 Number of new courses being added to course catalog/inventory: Number of courses being deleted from course catalog/inventory: Provide a brief summary of the reason for requested action (attach no more than one page if space provided is inadequate): Unlike traditional majors, the Bachelor of Science in Liberal & Applied Studies (BSLAS) major has only one required course - the Capstone (LAS 4991). Given the importance of this course to the program, and the highlevel goals and outcomes of the course, the course should be increased to 3 credit hours allow sufficient time and opportunities for students to meet these goals and outcomes. This recommendation is supported by the BSLAS Coordinating Committee. Additionally, external and annual program reviews have noted the need for additional assessment measures. As the Capstone course is the only course all LAS majors must take,

applicable, relevant, and useful assessment data must largely come from this course. Increasing the credit

hours will enable the implementation of additional assessment measures.

The purpose of the certificate in Nation-Building is to further prepare students with the perspective, historical knowledge, and leadership skills to be exceptional leaders informed in aspects of Native American Nation-building, honoring the past, shaping the present, and inspiring the future, throughout Indian Country and beyond.

2. Student enrollment in graduate level Native American Leadership programs and emphases, of which Native American Nation-Building is a core premise, has been historically steady, but increased significantly in the 2023-24 academic year. Enrollment in the MS Native American Leadership program, and Native American Leadership emphases within other SE graduate programs consistently averaged 69 students (range of 65-72) in the fall and spring semesters from 2021-2023. And enrollment in graduate programs with a Native American Leadership / Native American Populations emphases increased 23% (to 86) enrolled students in the fall and 32% (to 91) in spring of 2024. Furthermore, students, alumni, and tribal employers have expressed interest in additional graduate level curriculum and training in Nation-Building.

Student enrollment in graduate level Native American Leadership programs and emphases has been historically steady, but increased significantly in the 2023-24 academic year. Enrollment in the MS Native American Leadership program, and Native American Leadership emphases within other SE graduate programs consistently averaged 69 students (range of 65-72) in the fall and spring semesters from 2021-2023. And enrollment in graduate programs with a Native American Leadership / Native American Populations emphases increased 23% (to 86) enrolled students in the fall and 32% (to 91) in spring of 2024. Furthermore, the growth and development of tribal cultural centers and related programs and organizations focused on the management of cultural resources continues to increase. Tribal employers, students, and alumni have expressed interest in additional graduate level curriculum and training specifically in Cultural Resource Management.
