The second half of the tour was of the NSU Optometry Clinic which is under construction. The tour's narrative was conducted by Dr. Joseph Shetler, NSU Optometry Assistant Dean/Professor. Those attending included the host, President Hanley along with all the other RUSO Presidents, all of the RUSO Regents (except Ryan Walters), all the NSU Vice Presidents, RUSO Executives Brandon Tatum and Debra Lyon, along with several other NSU Executives and Staff.

The group toured all three floors, beginning with the first floor as you walk into the Eye Clinic and Retail Spaces.
