GBUS-1021 Business Environment and CMSC-3003 Data Management Systems will be removed from the curriculum and GBUS-3013 Business Communication will be added.

Justification for program requirement changes -provide a brief summary

The proposed change to the BAAS in Technical Management (Tracks 1 and 2) is the deletion of GBUS-1021 Business Environment from the foundation core courses. Business Environment was originally created as a professional development course for all Division of Business students. In 2020, the Division of Business added GBUS-3013 Business Communication to the core curriculum as a required class for all Business and Accounting students. Business Communications will now be required for all Technical Management majors. All topics covered in Business Environment are now covered in Business Communication. The addition of Business Communication will make Business Environment a redundant course in the program.

CMSC-3003 Data Management Systems will be removed from the curriculum for Track 1 and 2. Students will meet their computer proficiency while taking MIS-3413 Management Information Systems.
