Dear Board Members,

By way of introduction, my name is Dr. Melissa S. Caldwell, CCHP-MH/A, and I am a Clinical Forensic Psychologist and the President of Behavioral Health Services for Freedom Behavioral Health, Inc. I am writing to request your support in the field of corrections.

It has come to my attention that some correctional facilities are employing individuals who either lack appropriate licensure or are inadequately supervised to provide mental health care to incarcerated individuals. This includes tasks such as conducting assessments, providing therapy, and creating treatment plans without the necessary oversight from licensed professionals. Allowing these individuals to assume such responsibilities is not only a violation of professional standards, but it also puts vulnerable populations at risk.

The correctional setting presents unique and serious mental health challenges, including higher rates of mental illness and suicide.
