Recommendation that the Broward College District Board of Trustees authorize an increase in fiscal authority and amendment for a six-month extension with Advanced Roofing, Inc. and Hi-Tech Roofing & Sheet Metal Inc. (RFP-2020-020-EH - Roofing Services) to provide labor and materials for commercial roofing services collegewide. All remaining terms in the agreement remain the same. Fiscal Impact: \$1,000,000.00, Cumulative amount: \$6,000,000.00, Revenue: \$0.00

1.Describe the purpose of this purchase of goods, services, information technology, construction, or use of space. The College is requesting approval to exercise the contract amendment option for an additional 180-day term under the previously approved Roofing Services Collegewide (RFP-2020-020-EH) contracts. These contracts, with Advanced Roofing, Inc. and Hi-Tech Roofing & Sheet Metal, Inc., cover all labor and materials needed for commercial roofing services across the college. Services include roofing and building envelope waterproofing projects, as well as preventative maintenance, maintenance, repairs, replacements, and new installations. The work will address both scheduled and emergency needs, on a term contract basis, across the entire college.

Contract Period: 3-Year contract from May 4, 2020 to May 3, 2023.
