What is the purpose of this contract and why is it needed? This contract with Sullivan Electric & Pump provides maintenance and repair service to all types of pump equipment, irrigation, domestic water, booster stations, and sewage lift stations repairs. This vendor provides service that is crucial to the maintenance and repairs of our various pumping systems including our irrigation systems collegewide during FY2024-2025. This is imperative to the operation of the College.

What procurement process or bid waiver was used and why? Small purchase for Category One (\$0.00 - \$10,000) per College Procedure A6Hx2-6.34 was used, where there is no formal or informal competitive requirements for goods and services acquired by the College at this dollar threshold. One quote was obtained by per campus location to identify the best value for the required commodity or service.

What fund, cost center and line item(s) were used? Funds available in FD100 CC0143 (GLC 62500).
