What is the purpose of this contract and why is it needed? To renew an agreement with Miami Dade College for students who complete an associates degree so that they can transfer seamlessly in the Bachelors Program at Miami Dade College (MDC).

Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting? This is not a procurement and there is no cost for the agreement. Transfer office personnel are supported in through the approved budget.

**AMENDMENT NO. 1 ("AMENDMENT")
TO MEMORANDUM OF UNDERSTANDING ("MOU")**

This Amendment is made and entered into as of the last date signed below by and between The District Board of Trustees of Miami Dade College ("MDC") and The District Board of Trustees of Broward College ("BC") and amends that certain Memorandum of Understanding, entered into on May 14th, 2020, by and between MDC and BC (collectively referred to as the "Parties").

WHEREAS, the purpose of the MOU is to create a transfer pathway that allows graduates of BC's Associate in Science (AS) in Film Production Technology Program to seamlessly enroll into MDC's Bachelor of Applied Science (BAS) in Film, Television, and Digital Production;

WHEREAS, Article V. A of the MOU provides that the MOU may be renewed by written agreement of the parties for two (2) additional three-year terms; and

WHEREAS, the Parties each desire and agree to renew the MOU as follows:

- 1) To renew the term of the MOU for an additional three years retroactively effective from date of May 14, 2023.
