



EXECUTIVE SUMMARY

Broward College District Board of Trustees authorized the bid waivers and reports pursuant to College Procedure 6Hx2.6.34 for FY2021-2022 and FY2022-2023. Fiscal Impact: \$2,604,329.37 for FY2021-2022 and \$2,939,077.31 for FY2022-2023.

What is the purpose of this contract and why is it needed? This is a report to the District Board of Trustees pursuant to College Procedure A6Hx2-6.34 - Procurement Procedures. In order to expedite and streamline the approval of different type of bid waivers, a revision to College Procedure A6Hx2-6.34 was approved and went into effect on 01/02/2019. This process allows the College to exempt the requirements to solicit competitive offers for goods and services (bid waivers) in a more expeditious manner without processing through MinuteTraq. This revision authorized the Procurement Department through the current ERP System (Workday), to approve the issuance of bid waiver requests that do not have a corresponding contract and do not exceed Category Five, Section 287.017, Florida Statutes, currently at \$325K. In the event any bid waiver(s) for any vendor exceeds Category Five or the total of or for the fiscal year, it will be submitted through the College's Contract Management System (MinuteTraq).

The reports in this MT item cover the fiscal years FY2021-2022 and FY2022-2023 which were pending submission in MinuteTraq and presentation to BOT due to the high turnover rate and/or vacancy of the AVP Procurement position in the last two complete fiscal years, in addition to staff shortages.

With the change introduced by the new BOT to College Policy 6Hx2-1.14 - Contracts and Authority on 06/27/2023, bid waivers authorized by Procurement have been significantly reduced since the aforementioned policy now establishes: "Execution of Management Consulting or Services Contracts, Florida Statutes 287.017. The Board shall vote on any contract that seeks to provide the College with advise or services." Therefore, basically any management consulting or services contract (including purchase orders which are considered contracts) requires Board approval/vote regardless of the amount.

For reference purposes, the cumulative amount in dollar value of bid waivers authorized by the Procurement Department per College Procedure A6Hx2-6.34 for the period 07/01/2023 to 03/31/2024 (first three quarters of FY2023-2024) is \$713,952.94, mainly for goods per bid waivers for single or sole source materials, educational materials, library materials, and/or food. Several professional services bid waivers were approved in the first quarter of FY2023-2024 (July to September 2023) for requisitions and/or purchases orders already in progress or transit during the new BOT procedural change.

What procurement process or bid waiver was used and why? Bid waiver exemption per Florida Department of Education Administrative Rule 6A-14.0734 and College Procedure A6Hx2-6.34 which establishes that: "Bid Waiver requests that do not have a corresponding contract and do not exceed Category Five, section 287.017, Florida Statutes, shall be submitted through the College's enterprise resource management system. Bid Waiver Authorization requests fitting the parameters of this paragraph should not be submitted to the College's contract management system, and will be reported to The District Board of Trustees on a quarterly basis. All Bid Waiver requests that exceed Category Five, section 287.017, Florida Statutes, should be submitted to the College's

contract management system. Furthermore, any Bid Waiver requests with a corresponding contract should be submitted to the College's contract management system."
