



## EXECUTIVE SUMMARY

**Recommendation that the Broward College District Board of Trustees authorize the non-standard agreement with GE Healthcare for the repair services of the Eclipse Proteus Collimator in the radiography lab. Fiscal Impact: \$23,377.00.**

**What is the purpose of this contract and why is it needed?** The purpose of the contract with GE Healthcare is to repair the collimator of the GE X-ray equipment that is currently not functioning located in Building 8 Room 208 for the Radiography Program. The benefit of this machine is to give students hands-on experience for the success of their educational experience and to satisfy course requirements for practical experiences in their program of study.

**What procurement process or bid waiver was used and why?** The procurement process used was the informal competitive process where three quotes were requested per College Procedure A6Hx2-6.34. Selected vendor to perform the services is GE HealthCare, because they are the manufacturer and seller of the equipment. Other vendors informed that they do not service the equipment.

**Is this a budgeted expenditure from the budget established at the last June Board of Trustees meeting?**  
Yes.

**What fund, cost center and line item(s) were used?** FD100, CC087.

**Has Broward College used this vendor before for these products or services?** Yes, Broward College has used GE Healthcare to purchase products and repairs in the past.

**Was the product or service acceptable in the past?** The products and services from GE have been acceptable in the past and have allowed students to complete lab based competencies in a safe controlled environment prior to attending off-campus clinical externships.

**Was there a return on investment anticipated when entering this contract?** The return on investment is anticipated that the machine will be functioning in order for students to gain the experience necessary to achieve their educational success in the Radiography Program and complete.

**Was that return on investment not met, met, or exceeded and how?** The return on investment has been met as many students have benefited from the training and usage of the GE X-Ray machine as well as other GE products for the past 20 years.

**Does this directly or indirectly feed one of the Social Enterprise tactics and how?** This contract feeds the Social Enterprise tactic-Answer the Call for Healthcare Professionals and Actualize Employment tactics. It will Provide competent Radiography Technicians upon graduation who can fill the current need in the community and provide the student with well paying workforce opportunities.

**Did the vendor amend Broward College's legal terms and conditions [to be answered by the Legal Office] if the College's standard contract was used and was this acceptable to the Legal Office?**
