Recommendation that the Broward College District Board of Trustees authorize an amendment to the original subaward agreement with Daytona State College on the Florida Job Growth Workforce Training Grant

1.Describe the purpose of the grant.

In 2023, Broward College received a Florida Job Growth Workforce Training Grant from the Florida Department of Economic Opportunity (now Florida Commerce) in the amount of \$6.7 Million to provide CDL training and address a shortage in the commercial driving workforce. The grant included subawards of \$1.3 million for Daytona State College, \$1.5 million for Northwest Florida State College, and \$1.3 million for Valencia College. This amendment will modify the scope of work of the subaward agreement with Daytona State College allowing Daytona State to use an amount not to exceed \$47,395 in grant funds to complete renovations and installations in the parking lot where CDL training is provided. A copy of the original subaward agreement is included here. This amendment has been reviewed and approved by Florida Commerce (formerly FL Department of Economic Opportunity). This amendment does not change any of the original award amounts.

2.Describe the College's plans for meeting the grant requirements. Include details such as staffing plan and how any match requirements will be met.

Broward College and the three partner colleges have successfully met their initial targets for numbers of students trained to receive their CDL, are all on track to meet our mid-point targets for students trained and to spend all grant funds by June 2026, as outlined in Broward College's agreement with the Department of Economic Opportunity (DEO). Training will continue beyond June 2026, until a total of more than 9,000 individuals receive CDL training from the partner institutions. Broward College and the three partner colleges submit reports to DEO quarterly and are in compliance with all requirements and guidelines established by the Department. We work closely with DEO staff to address any modifications to plans that are needed and may request approval to use grant funds for facility renovations and improvements that are aligned with our CDL training goals.

WHEREAS, BC and Subrecipient are parties to that certain Florida Job Growth Workforce Training Grant Agreement dated on or about June 7, 2023 (the "Agreement"), and

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the terms and conditions set forth herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to amend the Agreement as follows:

- 1. <u>Amendment to Exhibit A SCOPE OF WORK</u>. The Scope of Work is hereby amended as follows:
 - a. **Amendment to Section 2 Grantee's Responsibilities.** Section 2 of Exhibit A to the Agreement is hereby amended to include the following new item:
