



EXECUTIVE SUMMARY

Recommendation that the Broward College District Board of Trustees authorize the standard agreement (purchase order) with the American Society of Composers Authors and Publishers for Music membership renewal and dues for Broward College utilizing the bid waiver for sole source. Fiscal Impact: \$14,439.53.

What is the purpose of this contract and why is it needed? ASCAP requires educational institutions to be member organizations if they wish to perform (live or recorded) any titles managed by ASCAP. This coverage includes use by student services, student life, and academic affairs - including musical and theatrical performances. This membership is held by many post-secondary academic institutions.

What procurement process or bid waiver was used and why? Bid waiver exemption used is sole source per FLDOE Rule 6A-14.0734 and College Procedure A6Hx2-14.0734.
