1. Describe the purpose of this purchase of goods, services, information technology, construction, or use of space. The purpose of this purchase is to establish Broward College's Department of Nursing as an active member of the Organization for Associate Degree Nursing (OADN), a leading national advocate for associate degree nursing education. This strategic membership aims to position our nursing program within a broader network of ASN programs, enabling collaborative partnerships and access to cutting-edge educational resources. Through this affiliation, we seek to strengthen our program's national presence while ensuring our curriculum and teaching methodologies align with current industry standards and best practices. The membership will facilitate meaningful connections with healthcare providers, industry leaders, and peer institutions, creating opportunities for enhanced clinical placements and community engagement.
