Re: December 2024 Warrants

1) PAYROLL: A historical analysis indicates that the December 2024 payroll warrants are higher than the prior year and twenty-four-month average, but lower than the six and twelve-month averages. This increase is primarily attributed to Broward College's participation in the State Group Insurance Plan (SGIP). The decrease is mainly due to the accrued leave payouts from the prior year.
