Re: November 2024 Warrants

1) PAYROLL: A historical analysis indicates that the November 2024 payroll warrants are lower than the prior year and six-month averages, but slightly higher than the twelve and twenty-four-month averages. This decrease is primarily due to changes in personnel salaries and less leave payouts compared to the prior year.
