BACKGROUND:

a. Summary of the request

The University of Maine System acting through the University of Maine at Augusta requests authorization to extend the lease of 6,022 square feet of office, classroom, and meeting space at 248 State St., Suite 1, Ellsworth Maine.

b. Overall requested budget and funding source(s):

The request is pursuant to Board of Trustees Policy 801 – Acquisition of Real Property, which requires leases with a total value of \$100,000 or more or a term of five (5) years or more to be considered by the Board of Trustees or the Finance, Facilities, and Technology Committee. The proposed duration of the lease is five (5) years with an initial cost of \$90,330. The total maximum cost over the duration of the lease is estimated to be approximately \$460,000.

c. Is the project included or reflected in the Master Plan, Long Term capital plan or 1year capital plan most recently approved by Trustees? If not, please explain why.

No, leased space is not included in the Master Plan or the Capital Plan.

d. Detailed explanation of rationale for project and metrics for success of the project (ROI or other)

This location has been used by UMA for several years to provide educational access to the students in the area. UMA runs in-person nursing cohorts and plans to run in-person Cyber Security classes beginning in the Fall 2025. Additionally, UMA and UMM recently agreed to a partnership where UMM nursing students will use the simulation rooms at the UMA Ellsworth Center during their Junior and Senior years.

e. Explanation of the scope and substance of the project as needed to supplement (a) through (d) above. Note: scope includes an explanation of community impact, how the project ties to the University's mission, etc.

The Downeast region of Maine continues to face challenges due to a lack of institutions equipped to support nursing clinics. By partnering with the University of Maine at Machias (UMM), the Ellsworth Center can help UMA and its sister institutions expand efforts to train and place much-needed nurses in the area. Place-bound nursing students will benefit significantly from the established simulation rooms.

f. Changes, if any, in net square footage or ongoing operating costs resulting from the project

The original lease called for a 5% escalator, however, the landlord agreed to hold the rent flat until 2029, when a 2.5% escalator would apply for the remaining two (2) years.

g. Alternatives that were considered to meet the need being addressed by this project

UMA looked at other locations in the Ellsworth area and found there to be no other solutions. Costs were higher than the current rate and would require total fit-outs.

The space is currently occupied by UMA and would not require any additional renovations or investments.
