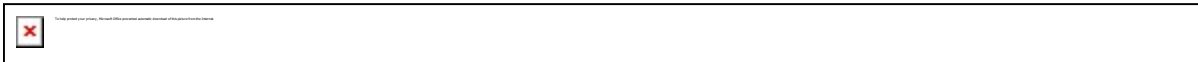

From the Office of the CEO

Led by Chair Katie Templeton, JD, the FSMB's Board of Directors is concluding a successful quarterly meeting today in Dallas, Texas. Among the many topics on the agenda, the board discussed collaborative opportunities via Zoom with leaders from the International Association of Medical Regulatory Authorities (IAMRA), including Chair Joan Simeon, who is CEO of the Medical Council of New Zealand, and Chair-elect Nicole Krishnaswami, JD, who is Executive Director of the Oregon Medical Board.

This afternoon, the board will meet with the Board of Directors of the **FSMB Foundation**, which is led by President Jan Rhyne, MD, a former FSMB Chair. As the philanthropic arm of FSMB, the Foundation funds and supports research and education initiatives that advance best practices in medical regulation and strengthen the safety and quality of healthcare.

During its 2024 grant cycle, the FSMB Foundation focused on assisting state medical boards with technology innovations, upgrades in board operations, and emergency preparedness. Nearly \$400,000 was distributed by the Foundation to nine recipients, with individual grants of up to \$50,000 – marking the largest in the Foundation's history. Over the past decade, the FSMB Foundation has provided more than \$1 million in grant support for a wide range of research and education projects.
