TRANSPORTATION AND SOLID WASTE COMMITTEE MEETING MINUTES

The Lee County Transportation and Solid Waste Committee met at 8:00 A.M. on the above date. The following members were present: Doug Farster (Via Telecom), Marilyn Shippert, Kasey Considine, Mike Zeman, and Mike Book (Via Zoom). Also Present: County Engineer David Anderson

Motion by Shippert: To approve the minutes from the February meeting as presented. **Second by Zeman:** *Motion carried.*

County Highway Report:

Mr. Anderson reported on the following:

- The Franklin Road HMA project was let in Springfield on 1/25/22. Martin and Company was awarded the bid for \$988,643.79.
- Approximately 100 routine NBIS bridge inspections that were scheduled for 2022 have been completed. Upon review of a summary sheet, it was noted that there will be several bridges requiring rehabilitation or complete replacement in the coming years on the County Highway system.
- The proposed ARPA request for a box culvert replacement was reviewed by the committee.
- In order to accommodate all of the salt the Department is contractually obligated to receive, all available storage facilities will be completely filled, including an outside storage bin covered with a tarp. After all facilities are full, approximately 300 tons will remain. The remaining 300 tons will be assessed a storage fee by the supplier per the CMS contract.

The committee opened the bids in the table below. **Motion by Shippert:** To award the following bids subject to Highway Commissioner concurrence, as applicable, and IDOT review. **Second by Zeman:** *Motion carried.*
