

### **Executive Committee Meeting Minutes**

#### I. Call to Order

Meeting was called to order at 11:00 a.m., by Vice Chair Tom Kitson.

II. IV. <u>Approval of the Minutes from the Previous Meeting - (December 12, 2024)</u>
Minutes from the December 12, 2024, Executive Committee Meeting were approved as presented without modification.

#### V. Reports from Committee Chairs

All committee chairs took the opportunity to report items discussed and motioned forward during their committee meetings.

During the reports, Jack Skrogstad asked Alice Henkel to walk the committee through the Petition to amend Financial Surety for Decommissioning for Maples Road Solar, LLC/Zoning Department item that was the agenda. Following is the information she shared during the County Services Committee meeting and Executive:

• Under Ordinance No. 11-22-008, once the Zoning Administrator has approved the cost estimate for decommissioning, "the Applicant shall deposit, in the

County escrow account, unless the County Board in its sole discretion agrees to accept alternative security, or a portion thereof, in the form a security bond approved by the County, an amount of one hundred twenty-five percent (125%) of the estimate, so as to cover the cost of decommissioning as well as inflation cost in future years. The value of surety shall not be reduced based on the salvage value of any materials or equipment." Maples Road Solar, LLC wishes to deviate from the ordinance in that they are requesting a decommissioning surety bond or letter of credit of roughly \$1 million which would be 125% of the decommissioning amount required. Alice made the members aware that the County had allowed a letter of credit from companies in the past that also included an administrative fee.

## VI. <u>Monthly Sheriff's Office Report Detailing Events Within the Department - Information</u> Only

Clay Whelan asked that his report from Public Safety be added to the Executive Committee agenda so Board Members would be up to speed on the events happening at the Sheriff's Office.

#### VII. Administrator Report

Jeremy Englund reported the following information regarding the BEAD Grant (Broadband Equity, Access, and Deployment), the RAISE Grant Application (Rebuilding American Infrastructure with Sustainability and Equity), and an update on the HR hire. Details are below:

- Illinois was awarded slightly over \$1 billion dollars for Broadband infrastructure expansion throughout the state.
- The state is currently working towards phase one within the project.
- Lee County currently has the highest eligible Broadband serviceable locations in the state that are able to receive BEAD funding. Lee County, out of the entire state, has the highest unserved or needed serviceable locations; roughly 8,300, eligible for BEAD funding. The next highest is Ogle County, which has 6,300.
- The County is currently working with four (4) service providers that are crafting draft applications for the first phase of the project which targets the hardest to serve areas.
- Wave two (2) of the project will hopefully start in the Spring of 2025 and target the remaining locations.
- The County is working on the RAISE Planning Grant application of \$1.5 million dollars in partnership with Sauk Valley College and the Reagan Mass Transit District. The grant would be for a multi-use path from the City of Dixon to Sauk Valley College. The application is due by January 30th.
- This is the fourth application that the County has submitted for the grant. Jeremy Englund and Greg Gates met with the feds after the last submission to get a better grasp on what could be done to achieve a better response.

As of January 10th, the County started to review over 100 candidates for the newly approved Human Resource position. The hiring committee will be coming together to start the interview process.

Andy Shaw explained that the first request for amendment is in connection with the Fun on 52 project and a project at the gate of Woodhaven, both with the same investor. The second request is in connection with the HA International industrial project expansion just outside of Oregon, IL. The third request is in connection with Constellation and a substantial expansion at the Byron Clean Energy Center that will include the installation of six (6) low pressure turbines, two (2) high pressure turbines, and electrical upgrades.

#### D. Truth in Taxation Per Diem

Tom Kitson explained that not paying Board Members per diem for the November 21st, Truth in Taxation Meeting was discussed during the December Executive Committee Meeting, but because it was not on the agenda, no action was taken. On November 21, 2024, there was a 5:30 p.m., Truth in Taxation Meeting, followed by a 6:00 p.m., County Board Meeting. Per diem is paid to Board Members per meeting. Because the meetings were back-to-back, the suggestion was made to not pay members for the Truth in Taxation Meeting.


