

<u>American Rescue Plan Act (ARPA) Committee</u> <u>Meeting Minutes</u>

Lee County, Illinois May 5, 2022 at 9:00 AM CDT Old Lee County Courthouse, Third Floor, 112 E 2nd St, Dixon, IL 61021

I. Call to Order

The meeting was called to order at 8:58 a.m., by member Tim Bivins.

II. Roll Call - Board Members - Bob Olson, Chair, Jim Schielein, John Nicholson, Chris Norberg, Rick Humphrey, and Tim Bivins

Chair Bob Olson was absent. All other Board Members were present in person.

III. Committee Members - John Simonton, Kevin Lalley, Charley Boonstra, Sara Leisner, Patty Rudolphi, Paul Rudolphi, Wendy Ryerson

Charley Boonstra and Kevin Lalley were absent. All other committee members were present in person.

Also present: Tom Wilson, Mike Book, Lirim Mimini (County Board Members), Dave Anderson (Highway/County Engineer), Greg Saunders (Maintenance Supervisor), and Becky Brenner (Board Secretary) were all present in person.

IV. Approval of Minutes (April 7, 2022 meeting)

<u>Motion</u> to approve the minutes from the April 7, 2022, American Rescue Plan Act (ARPA) Meeting. <u>Moved</u> by John Nicholson. <u>Second</u> by Jim Schielein. <u>Motion</u> moved unanimously by voice vote.

V. Visitors

Visitors present: Dr. Aaqil Khan (KSB Hospital), Chris Tennyson (ROE), Cathy Ferguson-Allen (Health Department Administrator), Liz Bedford (Clipper Kiddies Christian Preschool), Jeff Stauter (Kreider Services), Chief Ryan Bruskohl (Dixon City Fire Department), Chief Jeff Bryant (Amboy Fire Department), Patrick Krager (EMS Coordinator for Dixon Rural Fire Department), Jason Anderson (Economic Development Director at GREDCO for the City of Rochelle), and Andy Shaw (Zone Administrator at Lee Ogle Enterprise Zone in Rock Falls).

VI. Monthly PowerPoint Presentation

Sara Leisner walked the committee through the attached PowerPoint presentation and summaries, which will be added to the end of the minutes. She explained that there were three (3) items on the agenda that would required action. All other items and presentations would be reviewed by the committee and added to the agenda for June's meeting to be voted on.

VII. Old Business - No old business items

There were no items under old business.

- VIII. New Business
 - A. Outstanding ARPA Funds Requests to Review
 - 1. Health Department/ROE/KSB-Cathy Ferguson-Allen

Dr. Aaqil Khan, Chris Tennyson, and Cathy Ferguson-Allen Lee County Health Department Administrator walked the committee through their request for a school based mobile health clinic that would require a large van or RV that would be fitted to provide space for clinical, behavioral, vision, dental and/or audiological services. The capital expenditure of \$465,000 is being requested. The full PowerPoint presentation that was submitted to the committee by the group will be added to the end of the minutes.

2. Clipper Kiddies Preschool-Liz Bedford

Liz Bedford explained that due to Covid-19 the preschool was required to close which translated into significantly lower enrollment rates and diminished fund raising efforts. A recent fund raiser brought in \$4,000 which could be subtracted from the requested amount of \$15,000.

3. Kreider (3 requests) - Jeff Stauter

Jeff Stauter walked the committee through the three (3) requests submitted by Kreider services. The first request was for \$11,209.38 for covid testing kits to test unvaccinated staff, exposures, and outbreaks. The second request was for \$200,000 for frontline staff bonuses. The third request was for the purchase of an irrigation system at the Timber Creek Golf Course that Kreider had the opportunity to buy for \$1. The amount requested for the irrigation system was \$800,000. The property would not be purchased if the funding for the irrigation system is not funded.

4. Lee County Fire Chiefs - Ryan Buskohl

Fire Chief Buskohl addressed the committee on behalf of all the fire departments in Lee County with a request of \$450,000 to purchase and construct a live-fire training facility.

5. Amboy Fire Department - Chief Bryant

Fire Chief Jeff Bryant addressed the committee with his request for a trailer mounted mobile sign for \$17,945.

6. Dixon Rural Fire Department - Chief Aurand

Patrick Krager walked the committee through the request from the Dixon Rural Fire Department for a Lucas 3 Compression Device for the cost of \$15,579. The devise would help reduce the risks of Covid-19 exposure, help retain personnel, prevent injury, and decrease potential liability from equipment failure, while saving lives in the community and maintaining the the wellbeing of the first responders.

7. Historic Dixon Theatre - Action Item

Support for this project had previously been pledged, but was not voted on because the grant had not been awarded. Wendy Ryerson explained that the grant had been awarded, so the pledged support needed to be addressed by a motion.

<u>Motion</u> to approve \$100,000 for the Historic Dixon Theatre renovation project and move to the Finance Committee for approval. <u>Moved</u> by Chris Norberg. <u>Second</u> by John Nicholson. <u>Motion</u> passed unanimously by voice vote.

8. IDOT Raise Planning Grant - Action Item

Wendy explained that this topic had been brought to the County by the City of Dixon after the March ARPA meeting. The deadline to apply for the grant was quickly approaching, so the topic was discussed in the March Finance Committee Meeting and moved to the March County Board meeting, where it was approved. However, a formal application had never been submitted to the ARPA committee. The motion passed in the March County Board meeting was to approve the \$5,000 for the benefit cost analysis and up to \$50,000 of "match" funds.

<u>Motion</u> to approve \$55,000 from ARPA funds for the grant writing, engineering study, and cost sharing for the project and move to the

Finance Committee for approval. <u>Moved</u> by Jim Schielein. <u>Second</u> by Chris Norberg. <u>Motion</u> passed 5 yes, 1 no.

9. Planning grant for Traffic Analysis around Steward/Rochelle Industrial Park - Jason Anderson - Action Item

Jason Anderson explained that the EDA (Economic Development Administration) has a program whereby they will fund economic development planning studies. There is a 1000 acre area South of Rochelle, in Lee County, where the City of Rochelle, Rochelle municipal utilities, and the railroads have been building infrastructure. The strategy is to have a study done of this area that would provide specific information regarding what needs to be done and where, to make the area desirable to sight selectors. Equally as important is to assure the sight selectors that there is a comprehensive plan for funding and development of the area. He went on to explain that that they would like to get financial support to complete a study in this area to see where the utility easements need to lie and how a transportation plan can be developed. There is a \$250,000 grant that will fund the study that requires a 50% match. \$50,000 has been committed by the Lee Ogle Enterprise Zone Board. Jason and Andy were hoping that the County would fund the remaining \$75,000.

<u>Motion</u> to recommend the approval of \$75,000 of ARPA funds from the Economic Development category to the Finance Committee. <u>Moved</u> by John Nicholson. <u>Second</u> by Jim Schielein. <u>Motion</u> passed unanimously by voice vote.

10. EMA - Kevin Lalley

Kevin Lalley was not able to attend the meeting, but will be attending the June meeting.

11. Summary of requests to review at June meeting

Sara Leisner summarized the requests that will be coming to the meeting in June and reported that to date she has received ten (10) small business program requests.



- 6% of population uninsured

 - Federal Health Professional Shortage Area for Mental Health, Dental, and Primary Care Services
 - Medically Underserved Area for primary care, mental health, and dental
- \$57,600 median household income for our residents (approx. \$12,000 less than state level)
- 47% of students on free/reduced lunch; 17% of children living in poverty
- 60% of Lee County adults have 1+ chronic disease (vs 51% for IL)
 - 36% Obesity (vs 32% for IL)

Limitations of Mobile Health Unit

• Barrier: Fragmentation of care

• SOLUTION: partnership with hospital, health department, behavioral health & social service agency as well as the use of a shared data warehouse to connect all entities

• Barrier: Financial issues

• SOLUTION: diverse funding streams such as grants, donations, philanthropic organizations, corporate sponsorship, partner foundations, and health insurance when applicable

• Barrier: Logistical challenges

• SOLUTION: MLC manager to coordinate staff, schedule, supplies, etc.



Staffing Model

- Mobilize Lee County Project Manager
- Variable depending the primary service(s) being provided
 - Clinical will require Advance Practice Provider and nursing support
 - Behavioral will require licensed counselor/therapist
 - Oral health will require dentist and/or dental hygienist
 - Eye & Vision will require an optometrist
- LCHD has an Advanced Practice Provider and nurses
- KSB has all needed positions except for oral health
- Local dentist(s)
