**LEE COUNTY ANIMAL CONTROL  
REVISED FEES AND FINES SCHEDULE**

WHEREAS, pursuant to Ordinance #07-22-001 adopted on July 21, 2022, the Lee County Board (Board) set forth consistent policies and procedures for the enforcement and administration of 10 ILCS 5/1 (Illinois Animal Control Act), 510 ILCS 70/3 (Humane Care for Animals Act); and 225 ILCS 605/ (Animal Welfare Act); and

WHEREAS, the Board wishes to set forth consistent fees and fines commensurate with Illinois Compiled Statutes, Ordinance 07-22-001, and the current costs of providing animal control services; and

WHEREAS, the Board wishes to publish the fees/fines schedule for the benefit of Lee County citizens.

NOW, THEREFORE, BE IT RESOLVED the Lee County Board hereby repeals all previous Animal Control fees and fines schedules, and adopts the revised schedule heretofore attached as Exhibit A, effective upon passage.
