I. Call to Order

Meeting was called to order at 9:00 a.m., by Chair Jack Skrogstad.

II. Committee Member Roll Call: Chair Jack Skrogstad, Vice Chair Ali Huss, Dean Freil, Katie White, Ron Gascoigne, Reed Akre

After calling the meeting to order, Jack Skrogstad appointed Board Member Keane Hudson to the committee to satisfy quorum. Jack Skrogstad, Dean Freil, Reed Akre, and Keane Hudson attended in person. Ali Huss attended via Zoom. Katie White and Ron Gascoigne were absent.

Dave Anderson explained that the MFT (Motor Fuel Tax) Maintenance Appropriations Resolution reflected the amount that was approved during the FY2025 budget process. The Highway Department is not able to expend any of

these funds until the resolution is approved by the County Board and authorized by IDOT.

XI. Veterans Assistance

A. *Additional Full Time Veterans Service Officer (VSO) - Discussion Only*

Jim Gorman shared his background with the VA and Lee County and provided information regarding the future ask for a Veterans Service Office (VSO).

- Jim explained that he had been the Veterans Assistant Commission Superintendent in Lee County for going on ten (10) years. He is considered a part-time employee that works four (4) days a week for four (4) hours a day in the New Courts Building, on the first floor.
- The office is state mandated and funded by real estate taxes.
- 80% of his job is providing transportation for veterans to hospital and clinic appointments.
- Before COVID the office had 16 (sixteen) volunteer drivers. The number has dwindled to five (5).
- The office provides rental and food assistance to veterans that were honorably discharged with an income of less than \$25,000 per year.
- Additions to the Military Veteran's Act in the last couple years include the placement of one Veteran's Service Officer (VSO) per County. There are 102 counties in Illinois and currently only 62 counties have a VSO in office.
- For the last three (3) years Lee County has been using the VSO in Ogle County. In the last two (2) years the VSO in Ogle County has seen 119 Veterans from Lee County.
- There is an Illinois Department of Veterans Affairs Office in Sterling.
- Having a VSO in Lee County would mean that Veterans could file claims and get help with appeals in Lee County instead of having to travel to a nearby county.
- The act that spells out the changes is 33 ILCS 45 - Military Veterans Assistance Act.
- The new VSO position would have to be certified and work a minimum of 20 hours per week.
- Discussion on this topic has started so the position could potentially be included in the FY2025 Budget Ordinance.

XII. Zoning / Planning

Alice Henkel walked the Committee through the detailed report that she submitted. The full report will be attached to the minutes and included in the December County Board agenda packet.

After the monthly report from Zoning, Alice asked Jared Yater to bring the committee up to speed on compliance enforcement. Following are highlights from Jared's report:

- He is working with several property owners to remove recreational vehicles.
- He has coordinated with a group of individuals that are helping to strip useable items off boats and RVs to reduce the amount of weight taken to the landfill.
- Through the junk title process, property owners are getting money from the salvage yards for relinquishing their inoperable or junk vehicles.
- The Zoning Office continues to work with property owners to remedy non-compliant issues.
- Four individuals have been cited for non-compliance.

Lee County Highway Department
Report to the County Services Committee – DECEMBER 2024

The following represents a report of notable Highway Department activities and explanations of requested board actions:

Status of Current Projects

- 2024 Construction projects are complete.
- Efforts are ongoing to set up and design 2025 projects for both the County and the Townships. Bid lettings for these projects will likely take place from January through May.

Other:

- Maintenance crews have all the equipment prepared for the snow and ice removal season.
- Maintenance crews will cut brush/trees and clean/grade ditches throughout the winter as the weather and ground conditions permit.
- Phase I engineering has begun on the recent property under option for a new Highway Department facility. The County has engaged Willett Hoffmann and Associates to assist as necessary.

Discussion Items:

Board Action Items:

- *Motor Fuel Tax Maintenance Appropriation Resolution*
This resolution appropriates Motor Fuel Tax funds for the basic materials and general maintenance work for 2025. This must be in place by the first of the year to expend MFT funds.

Solid Waste

Electronics collection is now closed for the season. It will re-open in April of 2025.



MONTHLY ASSESSMENT OFFICE REPORT
December 10, 2024 – County Services Committee

- Publication of the 2024 general reassessment townships and any properties with changes in their 2024 assessments was published on Wednesday December 4, 2024. Change of Assessment Notices were also mailed out that day to those parcels. The deadline to file a Board of Review Appeal is January 3rd, 2024. If anyone has any questions about their assessment or the appeal process, please refer them to our office.
- Congratulations to Mary Ackerson in our office who completed her Certified Illinois Assessment Officer training in the fall and has received her certification. In 2023 only one other employee besides myself had the certification. In 2024 it was our goal for two more employees to receive certification, which we accomplished. This certification gives our employees education and tools to perform their duties more accurately, efficiently and confidently.
- After FOIA discussion at our last department head meeting and receiving the reminder from Co Admin Jeremy Englund that updated FOIA notices are due by January 1, 2025, I decided to delegate the FOIA Officer designation to Carmella Zigler in our office. Carmella has completed the FOIA and OMA training and our notice has been updated.
- Our office has also been filling in the gap for field inspections as our primary field inspector has moved into more of a zoning inspections role. Office staff have been out in the field taking photos in Palmyra Township for the 2025 general reassessment year. Our GIS Department has been working with them on a new QuickCapture app to be used with a tablet that will enhance accuracy of photo placement and save time identifying/labeling pictures for upload back at the office. While our office has been able to do some of the fieldwork, we will not be able to carry the entire load. I am looking at some options for a contractual field person for the spring.
- Our GIS Department is always researching new and existing technologies to increase efficiency and accuracy in our workflows in the most cost-effective ways. In addition to QuickCapture that we have recently implemented, we are currently exploring options for replacing our FARMS and Parcel Administrator tools with applications that have more advanced capabilities and could also save on annual maintenance fees going forward.

1. Welcome to a new fiscal year! I remind the board that your IT Department is comprised of Jonathan Henrikson, Travis Null and myself. We partner with Syndeo Networks for network and server Infrastructure services, and the Illinois State Department of Innovation and Technology provides us with security software, audits and advice as needed. I'd also like to thank Mike McBride of the 911/ETSB for his support on a variety of projects throughout the year.
2. Probation - Travis Null is wrapping new computer deployments in the Probation Department and applying security updates to a variety of servers.
- 3 Courts/Circuit Clerk - Jonathan Henrikson is deploying some new laptops in New Courts and will soon be working with Syndeo Networks on some server upgrades
4. LEC – I'm a wrapping up some tablet and laptop software updates in advance of a Flex software update coming in January 2025.
5. County-wide – Migrating user PCs to Windows 11 in advance of Microsoft planned retirement of Windows 10 in October 2025.
6. Animal Control – IT temporarily relocated Animal Control computers during a new flooring installation and we should be returning the remainder of computer equipment to its original locations by December 17. (Hopefully before then.)
7. Upcoming projects include:
 - More new computer deployments in New Courts and LEC.
 - County-wide – reorganize, consolidate on-site login, domain servers.
 - Organize Cybersecurity response team and response team plan.

2) DEVELOPMENTS

a) Service Contract Discussions

- i) Initial discussions on potential service contracts have been had with Rochelle Community Hospital as well as KSB Hospital. Both of these are in the very preliminary stages, with good content from the initial meetings.

b) Transit Desert Grant / IDOT State Planning and Research

- i) The Transit Desert Study is moving forward with NIU Center on Governmental Studies as the project lead. NIU is working on setting up the first meeting with the Technical Advisory Committee.
- ii) Components of this study will include surveys, review of baseline data, focus groups and a Technical Advisory Committee. The timeline for this project will provide for a wrap up of all activities by the end of FY 2025 (June 30, 2025).
- iii) This project will look at the general “transportation needs” of residents in Lee and Ogle Counties, specifically those areas of the counties more remote in nature

c) Feasibility Studies: Dixon and Rochelle

- i) RMTD and RLS and Associates held an initial meeting with IDOT leadership about potential funding (operational and capital) for the initiation of the fixed routes in Dixon and Rochelle.
- ii) The Dixon Study wrapped up at the end of November, while the Rochelle Study will be completed by the end of December.
- iii) RLS will provide a presentation to the Ogle County Board during its December 17, 2024 meeting.

d) Auditing Services

- i) Wipfli, LLC has been awarded successful bidder to the Request for Proposals for “Auditing” services, a three-year contract with two option years.
 - (1) Admin is working with Wipfli staff on the transportation audit, which is due into IDOT by December 31, 2024.
 - (2) This audit assesses the Downstate Operating Assistance Program funding as well as 5311, 5311F and CARES (Covid) funding received in FY 2024 (July 1, 2023 – June 30, 2024).

e) IT Services

- i) Pre-Award Concurrence for the awarding the successful bid of Information Technology services is pending with IDOT.
 - (1) Awarding should be made this week (12/9/24).
 - (2) The chosen IT Firm will have a three-year contract with two (2) additional one-year options.
 - (3) A total of four (4) IT Firms responded to the RFP publicized by RMTD.

f) Pending Request for Bids / Intercity Bus

- i) An upcoming bid opportunity to operate Intercity Bus services on I-88 and I-39 will be forthcoming in the next six (6) months, with the selected operator beginning on July 1, 2025.

g) Request for Bids / Replacement Vehicles

- i) RMTD has an initial draft of a Request for Proposals for two (2) (possibly three) Ford Transit type vehicles, and which has been shared with IDOT for their initial review. This RFP will allow for the use of REBUILD 1 funding.

- h) Architectural/Engineering Firm / Oregon facility construction**
 - i) Pre-bid Concurrence paperwork is being finalized by Larson and Darby, our architects for the Oregon office construction, and will be submitted to Illinois Department of Transportation. Once concurred will allow for going out for the hiring of a General Contractor.
 - ii) Larson and Darby, architectural firm out of Rockford, is the architect/engineering firm hired for the Oregon Construction project. This project is part of RMTD application under REBUILD 1
- i) Rural Winnebago County Transit Services**
 - i) Working on Intergovernmental Agreement with Winnebago County to provide rural transit.
 - ii) Separate agreement being finalized for the contractual hiring of a person to be the PCOM (oversight) of the rural transit services being provided.
 - iii) The contractual budget proposed by IDOT for this new rural service is as follows:
 - (i) 5311 Contract: \$207,864
 - (ii) DOAP Contract: \$798,728
- j) Hydrogen Fuel Feasibility Study**
 - i) IDOT State Planning and Research Program is finalizing the execution of its agreement with RMTD.
 - ii) RMTD has been awarded funding from the State Planning and Research Program of IDOT for a total of \$300,000 to assess the feasibility of using hydrogen fuel cell vehicles and hydrogen fuel in rural Illinois.
 - iii) Once a contract has been executed, RMTD will broadcast a Request for Proposals for a Project Lead for the initiative.
- k) Budget/Contracts for FY 2025 (July 1, 2024 – June 30, 2025)**
 - (1) RMTD has executed all three (3) of its contracts for FY 2025.
 - (2) Contractual amounts for State Fiscal Year 2025 are as follows:
 - (a) 5311 Contract: \$283,450
 - (b) DOAP Contract: \$1,867,008
 - (c) 5311F Contract (I-88 and I-39): \$2,029,606
- l) Vehicle Procurement**
 - (1) Pending transfer of two (2) buses from an area non-profit.
 - (2) Pending transfer of two (2) 5310 vehicles from local non-profit here in Dixon.
 - (3) RMTD received was awarded 6 vehicles (2 minivans, 4 light duty buses) via IDOT's 2022 CVP Application. Delivery in 2025.
 - (4) RMTD collaboration with IDOT on a federal proposal to the Low/No Emission Grants.
 - (a) RMTD will procure two (2) electric buses via this proposal.

- a) Capital Funding / Community Project Funding | Representative Darin LaHood**
 - i) Funding includes construction of additional administrative space at Dixon Transit Center
- b) Capital Funding / REBUILD Round 1**
 - i) Funding provides for construction of new Oregon location
 - ii) Furnishings and equipment for Oregon facility
 - iii) Implementation of video surveillance cameras in 17 of RMTD's buses and minivans (completed)
 - iv) Three (3) new buses (Ford transit type vehicles)
- c) Capital Funding / REBUILD Round 2**
 - (1) RMTD Proposal will allow for the following:
 - (a) Two electric vehicles for use in the RMTD system
 - (b) Three (3) new offices at Reagan Transit Center and secured file room/storage room
 - (c) Develop new Conference Room between Reagan Transit Center and Mechanical Bay
 - (d) Geothermal and Solar technologies will be incorporated into complex
- d) Capital Funding / REBUILD Round 3**
 - i) RMTD will receive \$62,500 for the purchase of 2 service vehicles

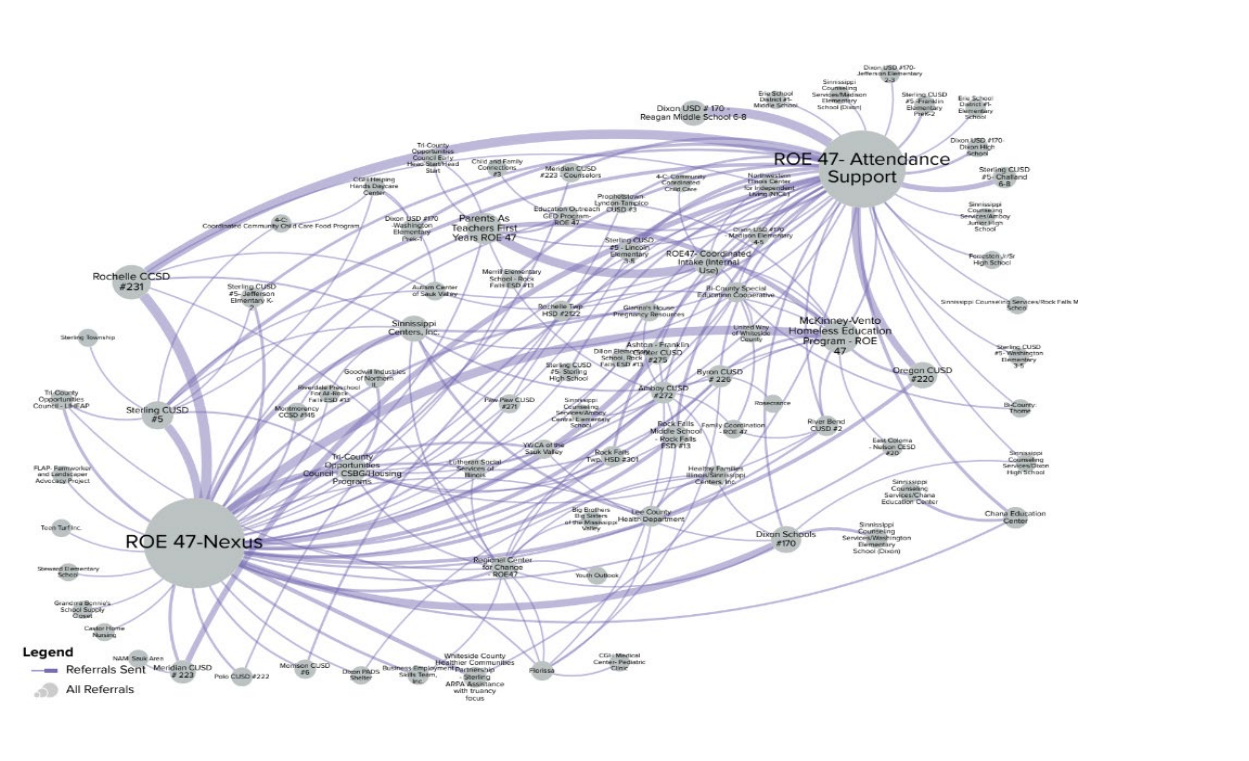

Office of Professional Learning & Ed Services: Professional Learning & School Improvement

- The Office Professional Learning & Educational Services is excited to announce that we have been awarded a Preschool for ALL Expansion grant through the Illinois State Board of Education. The grant proposed partnering with Dixon YMCA and Dreaming Tree preschool in Dixon to open four full day preschool classrooms serving 80 children ages 3-4.
- ROE 47 is partnering with the Illinois and National Science Teacher Association and the Illinois State Board of Education to provide statewide professional learning to support the implementation of the Illinois Science Standards in Fy 25.
- Active school with TRS-IA or RSSI plans to support trauma responsive schools include: Amboy Central Elementary, Amboy Jr High School, Amboy High School, Center for Change, Chana Educ Center, Southside School (Morrison), Polo High School, Rock Falls Middle School, Dillon Elementary (RF), Merrill Elementary (RF), Riverdale (RF), Lincoln Elementary (Sterling), Paw Paw Elementary & Jr High, Monroe Center, Sauk Valley Deanery.
- ROE 47 has launched a year-long social media campaign to raise awareness of trauma, reduce stigma, and promote resilience. Posts are available each Monday on Facebook.
 - *Childhood trauma leaves a lasting impact, affecting not only individuals but also generations to come. By raising awareness about the complexities of childhood trauma and promoting understanding, we can foster a more compassionate and supportive environment for children who have experienced these challenging events. Join us as we embark on a journey to create a resilient community where every child feels safe, seen, and heard. Together, we can break the cycle of trauma and empower individuals to heal and thrive.*

Office of Professional Learning & Ed Services: Parent Engagement & Community Outreach

- Over 20 families joined our November Parent University session on “Cracking the Code: Understanding Your Child’s Behavior”. Parent University sessions are held monthly on zoom at no cost to families.
- To date, ROE 47 has 142 partners on its IRIS referral platform. There have been 2,960 referrals and 1632 families served. IRIS is an Integrated Referral and Intake System that works to connect local agencies with one another to streamline online client referrals. IRIS supports warm hand-offs for families, closes the communication loop for referring organizations, tracks outcomes, and provides a clear data-driven picture of partner capacity to improve the process over time. The image below is called a kumu and demonstrates the interconnected nature of referrals made in the IRIS platform to date. ROE 47 is currently looking for sector champions (health care, childcare, etc.) and additional businesses to engage in a partnership pilot.

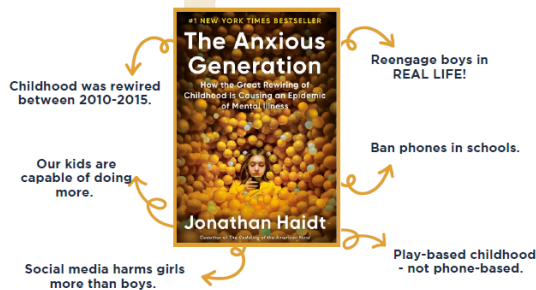

ROE 47 Computer Science Teacher Leader Program



Session One

The training emphasizes building a strong foundation in computer science education, covering topics like computational thinking, algorithms, programming, and integrating CS into different content areas. Parents as Teachers First Years

November brought news of an upcoming monitoring visit from our funder, the Illinois State Board of Education. Although this is an opportunity for growth, staff are always somewhat stressed by their visits. Part of the visit includes videotapes of home visits that the monitors then evaluate and recommend areas for improvement. The hardest part (besides staff worrying that everything has to be perfect) is convincing families to be willing to tape a home visit. Families often share very personal information and family stressors during their visits that they may not feel comfortable having on a videotape. We appreciate the family volunteers who are willing to let us videotape a visit so that we can use them as a tool to improve our services.

The program coordinator, Lois Meisenheimer, has been selected to serve on the Illinois Parents as Teachers State Office Advisory Council, which comprises 12 advisory board members from across the state. Members included 4 representatives from the state office, a representative from each of the two home-visiting funding agencies (the Illinois State Board of Education and the Illinois Department of Human Services), and 6 program supervisors. The inaugural meeting was held in November. Data was shared with the advisory board about statewide PAT affiliate programs which were quite notable. Across Illinois, 7,749 families were served by PAT programs last year, including 8,988 children. The Illinois state PAT office also provides more training annually than the PAT National office does, and overall, Illinois PAT programs meet quality standards and have more blue ribbon affiliates at a higher percentage rate than PAT programs nationally. The representative from IDHS was also impressed with the family retention rate and longevity of the families enrolled in PAT programs across the state which speaks volumes to the strength of relationships that are being developed and the opportunities for change and strengthening of families enrolled in PAT programs. We are thrilled to be able to represent this section of the state on this council and also to be part of such an impressive network of programs that are supporting families in this state.

Education Outreach Program

As November comes to an end and we prepare for the Winter season, the Education Outreach Program wants to take this time to be thankful for what we have and have worked hard for. For many of our students, they are setting and achieving their goals by coming to class regularly! We can officially say that we have consistent attendance and participation from our students. Due to this, testing is at an all time high. We had 5 students pass GED tests in November and already have 5 more scheduled for the first week of December! The students' are meeting their academic and personal goals, and our program is fulfilling grant requirements.



Also with the colder season ahead, the Education Outreach Program and the supportive staff have developed "Giving Trees" for our classrooms in Sterling and Oregon. We have had generous donations of hygiene supplies and hats so far and they are absolutely needed and used! It is a wonderful time of the year and we want to make sure all of our students get to feel cheerful and supported.

McKinney Vento Homeless Program

November is the National McKinney Vento Homeless Conference. It was held in Orlando and attended by over 2000 people. Great wealth of information and other State experiences makes this a great opportunity to learn more about this program and steps that others take to reach and support the children in their educational travels. I feel very fortunate that I was able to attend this year. Resources will be shared with our districts to help them better understand and serve our children.

Center For Change

December

As we close out the year and move into the winter months, we are excited to reflect on the progress we've made and share our plans for continued growth and engagement into the second semester.

This semester has been one of growth, connection, and success. Our October outing to Selmi's Pumpkin Patch was a wonderful experience for our students, providing them with an opportunity to connect with the community while enjoying hands-on, seasonal activities. The event was well-received by students and staff, reinforcing the importance of providing opportunities outside the classroom that promote social and emotional learning.

As we prepare for the second semester, we are introducing *monthly themes* centered on student growth and performance. These themes will focus on essential values such as:

- **Rewards for Attendance:** Encouraging consistent participation and recognizing students for their commitment to learning.
- **Showing Respect:** Reinforcing positive interactions and respect towards peers, staff, and the community.
- **Acts of Kindness:** Promoting compassion and teamwork within our school and beyond.

These monthly themes will help us build a stronger culture of achievement and positivity while recognizing and celebrating individual student successes.

MONTHLY ZONING AND PLANNING REPORT

December 10, 2024 – County Services Committee

ACTIONS COMING FROM THE ZONING BOARD OF APPEALS – None

ACTIONS GOING TO THE ZONING BOARD OF APPEALS –

1. Petition No. 24-P-1634 by Georgios Karountzos, as owner of certain real property identified as PIN 12-14-16-300-001 and commonly known as 823 Sterling Road, Dixon, Illinois, located on the south side of Sterling Road, approximately one-tenth of a mile east of Dutch Road and one-quarter mile west of Halligan Road, in Marion Township, Lee County, Illinois, filed a Petition for Special Use with the Lee County Zoning Office requesting a special use permit for the purpose of operating an auto repair business under the “Auto Repair – Minor” use classification as set forth in the Lee County Code . The parcel is currently zoned Ag-1, Rural/Agricultural District and is 5 acres in size.
2. Petition No. 24-P-1635 by Jake R. Kastner, as owner of certain real properties identified as PINs 07-02-34-300-022, 07-02-34-300-017, 07-02-34-300-035 and 07-02-34-300-018, located on the south side of Stony Point Road, in Dixon Township, Dixon, Illinois, filed a Petition for Map Amendment with the Lee County zoning Office requesting to amend the zoning map from R-2, Single Family Residential District to Ag-1, Rural/Agricultural District for the purpose of raising and keeping farm animals, more specifically, chickens.

OTHER ACTIONS FROM THE ZONING OFFICE

Following the November 7, 2024 meeting of the Zoning Board of Appeals, longtime member, Mike Pratt, submitted his resignation. Mr. Pratt was appointed to the Zoning Board of Appeals in December of 1994, and dutifully served Lee County for almost 30 years.

With the loss of yet another ZBA member and the agreement of the County Board, the Zoning Office has begun working with the State’s Attorney’s office on a text amendment to amend the zoning code to allow for a Zoning Hearing Officer in place of the Zoning Board of Appeals. We will be bringing a Petition for Text Amendment for public hearing before the Regional Planning Commission in February 2025.



At the request of the County Board, the Zoning Office is submitting with this report, a proposed moratorium on accepting zoning petitions for battery energy storage system and/or battery storage power stations until March 31, 2025. I am asking that this proposed moratorium be moved to the Executive Committee to be added the County Board's agenda this month.

Last month, the Zoning Office issued a building permit to Ameresco Lee County RNG, LLC for the installation of approximately 4.4 miles of pipeline in Lee County. This pipeline will carry renewable natural gas from the biogas facility located on Corregidor Road to a Kinder Morgan interconnection site located on Dutch Road.

The Zoning Office continues to work with the Maples Road Solar, LLC project for its application for building permit for a 5 MW community solar project. The issue of decommissioning financial surety needs to be resolved before the permit can be issued.

During the month of November 2024, the Zoning Office processed seventeen (17) building permits. Permit fees in the amount of \$2,711.50 were collected.
