Transfer of Credit

BACKGROUND / DISCUSSION

BOR Policy 2.2.2.1 – Seamless Transfer of Credit establishes requirements for institutions seeking to develop program level agreements for interested transfer students. The policy further establishes the distinction between AA, AS, and AAS degrees which are classified as transferable, terminal, or non-transferable degrees (respectively). However, the AAS is "transferable when a specific degree articulation agreement exists between a given A.A.S. degree and a specific Baccalaureate degree." Agreements established with regionally accredited institutions must be developed in conjunction with the faculty, following all institutional guidelines and are monitored as a function of the institutional program review process. Once approved, the agreements apply only at Regental institutions with equivalent programs.

IMPACT AND RECOMMENDATION

To comply with BOR Policy 2.2.2.1, Black Hills State University requests approval of following articulation agreements:

• Students who have completed an associate's degree in Western Wyoming Community College may apply the general education coursework credits toward all Bachelor's degrees at BHSU.

Associate to Bachelors (A2B) Articulation Agreement

Western Wyoming Community College And Black Hills State University

Agreement with Respect to Applying Credits to the General Education Requirements for All Bachelor's Degree Programs at BHSU

I. Parties

The parties to this agreement are Black Hills State University (BHSU) and Western Wyoming Community College (WWCC).

II. <u>Purpose</u>

The purpose of this agreement is to provide a seamless transfer of General Education credits for all students from WWCC seeking to continue their education at BHSU and subsequently all SDBOR universities.

III. Academic Program, General Education

The BHSU General Education program—consistent with guidelines of the SD BOR—requires 30 hours of credit in Composition, Oral Communication, Mathematics, Natural Sciences, Social Sciences, and Arts & Humanities. Some BHSU programs have additional institutional requirements for up to 6 hours, which are not considered in this agreement.

WWCC's General Education program requires at least 24 hours. Like BHSU, its program includes Composition, Oral Communication, Mathematics, and Natural Sciences. Unlike BHSU, WWCC divides its other requirements among the following categories: Creative Expression, Human Cultures, Human

Society and the Individual, Critical Thinking, and the Western Experience. The first three of these categories overlap with BHSU's Social Sciences and Arts & Humanities.

This agreement will allow for the transfer of all WWCC General Education credits into the BHSU General Education Program. Additional agreements will establish equivalencies for majors in Business and Education.

IV. General Education Block Transfer

Upon entering a bachelor's degree program at BHSU, a graduate from WWCC with an associate's degree will receive credit in the BHSU General Education Program for the 24 credits required in the WWCC General Education Program.

Where a WWCC course is for more credits than is required for the equated course at BHSU, the additional credit(s) may count as electives.

V. General Education Completion at BHSU

To complete the general education program at BHSU, students with an associate's degree from WWCC will take the following:

- English 201, Composition II (unless credit earned for ENGL 1020 from WWCC. This course is not required in WWCC's gen ed program).
- Any Course listed as satisfying BHSU's requirements for Goal #3 (Arts & Humanities) or Goal #4 (Social Sciences).

VI. Obligations

Both parties agree to confer as needed regarding changes in curricula involved in this articulation agreement.

VII. <u>Termination</u>

This agreement may be terminated by either party upon written notice of the other.

VIII. Effective Date of Agreement

August 1, 2025
