BACKGROUND / DISCUSSION

South Dakota State University (SDSU) requests approval to offer the undergraduate certificate in Wizipan Leadership and Sustainability at SDSU's main campus and online. The undergraduate certificate in Wizipan Leadership and Sustainability has been offered as a semester long experience through a partnership with the Indian University of North America at Crazy Horse Memorial. This delivery method created challenges for student completion of the certificate, including the requirement to complete all courses within one semester and the need to relocate for the term. Therefore, SDSU seeks to terminate delivery of the certificate at Indian University of North America at Crazy Horse Memorial and requests to offer the program on the Brookings main campus and online. The new delivery sites will allow SDSU to reach a broader range of students interested in learning about Indigenous perspectives on leadership and sustainability.

IMPACT AND RECOMMENDATION

SDSU requests no new resources, as all courses needed for the program are already offered either face-to-face in Brookings or online.

The School of American and Global Studies is in the process of developing online sections of AIS 100 Introduction to American Indian and Indigenous Studies.

6. How will the university provide student services comparable to those available for students on the main campus?

A faculty member or professional advisor will serve as the academic advisor to students.

Communication with distance students will be conducted using e-mail, phone, Zoom, and other technologies facilitating long-distance communication.

The Office of Continuing and Distance Education (CDE) provides support to new online and distance learners through a dedicated onboarding process, Orientation for Online Learners, and Virtual Move-In Day. CDE staff also provides ongoing support through enrollment and student success coordinators that are available to assist students in connecting to necessary resources online and on campus, through the SDSU Virtual Student Union, student success videos, online tutoring support through Tutor.com. Additional student services such as disability services

accommodations will be available to students upon request.

The South Dakota State University Hilton M. Briggs library has long served students engaged in coursework away from campus. This includes students enrolled online. Library support services will be available to students through a variety of means:

- Students can contact librarians for research assistance. The librarian provides online research guides and is available for consultations with faculty and students.
- Distance Library Services include book and article delivery for materials owned by the library. Students may request materials not held by the library through interlibrary loan.
- SDSU students have online access to research databases such as Web of Science, EBSCOhost MegaFILE, and JSTOR.
- 7. Is this program accredited by a specialized accrediting body? If so, address any program accreditation issues and costs related to offering the program at the new site(s).

The certificate is not accredited.

8. Does the university request any exceptions to Board policy for delivery at the new site(s)? Explain requests for exceptions to Board policy.

The current curriculum includes 15 credits. A substantive program modification is being submitted to reduce the total credits to 12-13. The variation in the total credits required for the certificate is related to the inclusion of a 4-credit introductory Lakota course as an elective. The inclusion of this elective is important for the language sustainability component of the certificate.
