BACKGROUND / DISCUSSION

Northern State University (NSU) requests authorization to offer a graduate certificate in Alternative Certification for General Education Teachers. The proposed certificate is designed to formally recognize and validate the completion of essential coursework and training for individuals seeking to meet state teaching requirements through the South Dakota Department of Education (DOE) alternative certification pathway.

IMPACT AND RECOMMENDATION

The proposed certificate will be offered on campus, online, and through HyFlex delivery. NSU does not request new resources. No new courses will be required.

Northern State University's graduate certificate in alternative certification for general education teachers is designed to formally recognize and validate the completion of essential coursework and training for individuals seeking to meet state teaching requirements through the SD Department of Education alternative certification pathway. This graduate certificate alone does not result in teacher certification; additional requirements must be fulfilled through the South Dakota Department of Education.

4. Provide a justification for the certificate program, including the potential benefits to students and potential workforce demand for those who graduate with the credential. NSU proposes establishing a graduate certificate in alternative certification for general education teachers to address critical academic, professional, and workforce needs. This initiative formalizes an existing and approved curriculum to meet state requirements, providing clear benefits for students, faculty, and South Dakota's educational system.

Offering a graduate certificate provides official recognition for individuals who complete the alternative certification coursework, elevating their professional credentials. This formal designation helps schools and districts easily identify candidates who meet the state's alternative certification standards, ensuring a qualified teacher workforce.

Without a certificate program, students pursuing alternative certification coursework are classified as non-degree seeking. Their programs of study are not visible in the NSU catalog or Degree Works, complicating progress tracking for students, faculty, and Graduate Studies staff. A certificate program would address these gaps by streamlining progress tracking, assigning advisors to support students, and ensuring clarity for all stakeholders.

Establishing a formal certificate program enables the Chair of Teacher Education to better plan course offerings, manage faculty workloads, and respond to enrollment demands. With an estimated 12 students currently pursuing alternative certification coursework at NSU, the program provides a structure to ensure efficient resource allocation and academic planning.

South Dakota introduced the alternative certification process for general education teachers on July 1, 2017, to address teacher shortages and provide career changers with a pathway into education. Currently, the state has 39 open positions for secondary teachers listed on the South Dakota Teacher Placement System.[1] Additionally, six secondary content areas are considered critical needs for the Dakota Corps Scholarship and the Critical Needs Teaching Scholarship. NSU's certificate program directly supports this state initiative by formally recognizing and promoting the preparation of qualified educators in these high-need areas.

The curriculum for alternative certification, approved by the South Dakota Department of Education, requires 12 transcripted credits in classroom management, teaching methods, student assessment, differentiated instruction, and adolescent psychology. Administrative rule also requires students complete a course in SD Indians in order to teach in the state, which adds another 3 credit course to the certificate. NSU already offers this coursework, making the addition of a formal certificate a natural and efficient enhancement to the existing framework.

Northern State University is approved by the SD Department of Education for alternative certification for general education, and Northern already offers all of the courses required for alternative certification. Northern has teachers pursuing alternative certification for general education taking Northern courses. Right now, Northern is tracking these students on an Excel file and manually updating the file, which is not efficient or an effective use of staff or technology systems. Formalizing the pathway in a graduate certificate enables Northern to better serve our students. Students seeking alternative certification in general education will have a program in Degree Works, have an assigned faculty advisor, and will earn a graduate certificate. The University of South Dakota offers an alternative certification program, allowing them to track the students pursuing this credential in Degree Works and in their program-seeking headcount.

By formalizing the pathway with a graduate certificate, Northern aligns with best practices in program delivery and recognition, offering students a streamlined, officially designated credential that meets the state's professional standards and that will appear on the student's transcript.

Students eligible to enroll in NSU's alternative certification for general education teachers graduate certificate program must first have been granted a Preliminary Alternative Teacher Certificate by the South Dakota Department of Education. Completing the coursework in NSU's alternative certification for general education teachers graduate certificate program is the next step toward obtaining a permanent alternative teaching certificate, also issued by the South Dakota Department of Education.

The certificate is a stand-alone educational credential issued to individuals pursuing alternative teacher certification through the South Dakota Department of Education. The coursework is designed to align with the specific requirements for alternative teacher certification established by the State of South Dakota.

Individuals seeking alternative certification from the state of South Dakota must complete the coursework contained in NSU's alternative certification for general education teachers graduate certificate program

The certificate is a stackable credential, and all credits can be applied to NSU's MSEd in Educational Studies: Secondary Education.

The curriculum is already recognized by the SD Department of Education as meeting the coursework requirements for the alternative certification pathway.

The curriculum for Northern's alternative certification for general education teachers graduate certificate program includes 5 courses already required in Northern's MSEd in Educational Studies: Secondary Education. These courses are already supported by Northern and taught on a regular basis by highly qualified faculty.
